Vendor Rules and Guidelines

IF YOU ARE AN ARTIST, PLEASE FILL OUT OUR ART VENDOR APPLICATION

- A submitted application does not imply acceptance. All applicants will be notified as to the status of their application upon arrival. A refundable \$400.00 security deposit will be required to secure a vendor space. Two weeks prior to the event is required for cancellation. Should an accepted applicant cancel after October 1st, the \$400.00 security deposit will NOT be refunded.
- 2. Vendors must provide all of their own props and equipment. This includes, but is not limited to, weights and tie-downs for securing tents. Trash containers, rest room facilities, and eating areas will be provided.
- 3. <u>Power will NOT be provided</u>. Vendors must provide their own generators in the event that they will need power.
- Booth and vendor set-up must be completed and ready to sell by 10:30am. Estimated event end time is 5:00pm.
- 5. All booth and vendor spaces will be outdoors. Sweet Life Concert Series events are rain or shine. In the case of dangerous inclement weather the City of Sugar Hill will inform vendors if the event will be rescheduled, unless otherwise stated.
- 6. Should an applicant not be accepted, any application fees or security deposits will be promptly returned.
- 7. Any vendor who misrepresents the content or intent of their booth will be asked to leave the event area, with NO refund.
- 8. Only food products and prizes approved by the City of Sugar Hill will be allowed to be sold at the event. You will be notified as to what will be approved for sale from your list of items on the application.
- 9. Only one vendor or business allowed per booth or vendor space.
- 10. Vendors are responsible for clean-up of their areas at the conclusion of the event. A \$400.00 refundable security deposit is required upon the acceptance of the application. Booths must remain open and shall not be dismantled prior to event ending. After the event, all merchandise must be packed and booth completely disassembled before vehicles will be allowed into event area for loading and departure.
- 11. Knives, firearms, fireworks, weapons, or other dangerous items MAY NOT be displayed or offered for sale.
