The City of Sugar Hill held a called Council Meeting on Thursday June 28, 2001 at 8:00 AM in the Community Center.

Notice of the meeting was placed on the doors of city hall and the community center. Notice was placed on the board at Peachtree Industrial Blvd and Alton Tucker Blvd. Notice was sent to the local newspapers.

Those present at the meeting included Mayor Roberta Crabb, Council Members Meg Avery, Kim Hall and Gary Pirkle. Also present were City Manager Bob Hail and City Clerk Shirley Gibbs. Absent were Mayor Pro-Tem Chris Abbey and Council Member Mike Mosley.

CALL TO ORDER, PLEDGE OF ALLEGIANCE TO THE FLAG AND INVOCATION:

Mayor Crabb called the meeting to order at 8:00 AM and led the Pledge of Allegiance to the Flag. Council Member Gary Pirkle gave the Invocation.

APPROVAL OF AGENGDA:

Council Member Avery made the motion to approve the agenda. Council Member Pirkle made the second. Motion passed unanimously by those present to vote. 3-0.

NEW BUSINESS:

A: PUBLIC HEARING: SET MILLAGE RATE FOR 2001:

Council Member Pirkle made the motion to enter into Public Hearing for the purpose of setting the Millage rate for 2001. Council Member Hall made the second. Motion passed unanimously by those present to vote. 3-0. City Manager Hail gave an explanation on the real growth in property over the last year, the increased cost of services and the cost to maintain those services. His suggestion was to keep its current Millage rate of 3.87. The council members had several questions concerning this item and if there could be a rollback in the Millage rate due to increased gas usage brought on by the increased growth. City Manager Hail felt the one-dollar overhead would not sustain the gas department even with the increased use of gas. There were no comments from the public. Council Member Pirkle made the motion to return to regular session. Council Member Hall made the second. Motion passed unanimously by those present to vote 3-0. Council Member Hall made the motion to keep the current Millage rate of 3.87 for the 2001 Property Taxes. Council Member Pirkle made the second. Motion passed unanimously by those present to vote 3-0.

B: CONTRACT AGREEMENT WITH THE DEPARTMENT OF CORRECTIONS:

City Manager Hail explained the contract for the prison crew that worked at the golf course would expire on July 1, 2001. It needed to be renewed in order to keep the crew working at the golf course. Discussion followed. Council Member Pirkle made the

C: PARK SIDEWALK AND SPECTATOR IMPROVEMENT:

City Manager Hail reported he had put out an RFP to get bids for sidewalks and spectator improvements at the park. He had received three bids, which had been opened on Wednesday June 27, 2001. He presented the council with the results of those bids. His recommendation was to go with Vaughan Concrete, which was the low bidder. Discussion followed. Council Member Hall made the motion to have Vaughan Concrete do the sidewalk and spectator improvements at the park based on their bid. Council Member Avery made the second. Motion passed unanimously by those present to vote 3-0.

EXECUTIVE SESSION: PERSONNEL ISSUES:

Council Member Pirkle made the motion to enter into Executive Session to discuss Personnel Issues. Council Member Hall made the second. Motion passed unanimously by those present to vote 3-0.

Council Member Pirkle made the motion to return to regular session. Council Member Avery made the second. Motion passed unanimously by those present to vote 3-0.
