HIGHWAY 20 – ROAD WIDENING PROJECT

Planning meetings with the State DOT and Gwinnett DOT continue. The road improvement layout plan is 95% completed and a Public Hearing is planned for late February or early March. This will be a chance for all citizens to ask their questions concerning the project. Depending on Right of Way land acquisition, construction may begin as early as the fall of 2007.

The project is to construct a four (4) lane divided highway with a 44 foot grass median. A Five (5) foot wide sidewalk will be constructed on both sides of the road from the Chattahoochee River to Peachtree Industrial Blvd. A second bridge will be built across the river south of the current bridge and connects with the road improvements in Forsyth County. This project will complete a four (4) lane road system from Hwy. 400 in Forsyth to Lawrenceville.

When the Public Hearing date is set, we will place the date and location in the newsletter, post it on the City Marquee on Alton Tucker and ads will be placed in the Gwinnett Daily Post. The City has a copy of the draft plan in City Hall.
