

The City of Sugar Hill
Plaza Security Patrol Actions
Aug.16th, 2016 – Aug.22nd, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 08-16-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. No incidents were observed by or reported to security personnel.
- 08-17-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. While on patrol in the area behind the businesses in The Sugar Hill Station shopping center in a 'blacked out mode' the Officer observed a subject standing by the dumpster and one in the dumpster behind the Value Village. The Officer activated his high beam headlights in order to illuminate the subjects and disorient them. Upon contact with the subjects the Officer advised the subjects that they were trespassing. The one subject in the dumpster advised that she had permission from one of the employees of Value Village to rummage through the trash. The Officer requested written proof of the permission of which neither subject had. The Officer then made the subjects put all the junk back in the dumpster and advised if he caught them again that he would request that GCPD issue a Criminal Trespass notice to them. The Officer obtained the subjects identifications and photographed them. After the mess was back in the dumpster the Officer advised the subjects to depart of which they did without incident. The Officer then went back in service. No other incidents or issues were observed by or reported to security personnel.
- 08-18-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. The Officer while on patrol in a blacked out mode behind the businesses at the Sugar Hill Station behind Value Village observed a subject with a flashlight in her mouth rummaging through the dumpster. The Officer then activated his high beams to illuminate the subject and disorient her. As the Officer exited his vehicle he inquired what the subject was doing other than trespassing. The Officer then requested identification. The subject then produced a Louisiana Driver's License, the Officer advised the subject to return all items to the dumpster and if he caught her again he would contact GCPD and request them to issue her a Criminal Trespass Warning and any further contact could result in incarceration. The Officer waited until the area was cleaned up and the subject departed without incident and then returned to service. No other issues or incidents were observed by or reported to security personnel.
- 08-19-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. While on patrol in the parking area the Officer observed a black passenger car in the extreme rear area off of Austin Garner Rd. without a tag and 3 subjects sitting in it. The Officer approached the vehicle and upon approaching the vehicle detected the strong odor of Black & Mild cigars. The Officer requested the subject's identifications and verified that all occupants were over 18 Y.O.A... Also the Officer requested the vehicle paperwork to verify that it had been recently been purchased. When the Officer requested who had been smoking Black & Mild? The rear passenger stated that he was and that he was not smoking marijuana. The Officer stated that they needed to find another place to hang out. The subjects left without incident. No other issues or incidents were observed by or reported to Plaza Security personnel.
- 08-20-16- Officer while on patrol made multiple area checks and also the city park for suspicious and/ or illegal activity/s. The Officer made routine patrols of both residential and business properties, including P.O.A.Ps. No incidents were observed by or reported to security personnel.
- 08-21-16- The Officer performed routine patrols of both business and residential properties including, but not neglecting the P.O.A.P.'s. No incidents were observed by or reported to Plaza Security L.L.C. personnel.
- 08-22-16- The Officer made routine patrols of both residential and business properties not neglecting the P.O.A.P.'s. No incidents were observed by or reported to security personnel.

- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek,

Hickory Hills and Benfield Road. Patrols also cover all other subdivisions.
