RECOMMENDED ACTION

Award the Construction Contract to Sunbelt Asphalt in the amount of \$1,393,427.50 for the completion of the 2018-2019 Roadway Resurfacing Program.

BUDGET IMPACT

The funds for the project have been budgeted in the 2019 Capital Improvement Plan with the sources being a combination of state grant money, general funds, and local SPLOST money totaling \$900,000. The state has already issued funds totaling \$414,156 toward the resurfacing project. With SPLOST receipts exceeding budgeted levels, staff recommends allocating an additional \$493,427 of those funds toward this project, bringing total funding available equal to the recommended contract amount.

DISCUSSION

Bid documents for the project were drafted in-house with assistance from our project management team and advertised in February. Ads were placed in the legal organ while the contracting opportunity was published on our website and GMA's website continuously during the bid period. Six prospective contractors picked up bid documents while two other plan rooms helped advertise the opportunity.

Bids were received on September 11, meeting the advertising regulations in place for this type of project. Six bids were received:

After reviewing the bids submitted and verifying the calculations on each pay item, staff determined the apparent low bidder to be <u>Sunbelt Asphalt</u>. After confirmation of their qualifications and pay items, staff is ready to recommend award of the construction contract as bid to Sunbelt Asphalt in the amount of \$1,393,427.50.


