Approve of Georgia Power Easement - Veteran's Memorial



Approval for the Mayor to sign an easement in favor of Georgia Power for the relocation of the electrical power lines, underground, for the construction of the Veteran's Memorial.

## **DISCUSSION**

As part of the Veteran's Memorial project at the Southwestern corner of the intersection of West Broad Street and Church Street, there is an existing Georgia Power electrical pole located within the project limits. Coordination with Georgia Power has provided a plan on the removal and relocation of the existing power pole to outside of the project limits and routing the existing overhead lines underground within the project limits while providing a 'loop' to feed power to City Hall.

The associated Construction documents have been signed by the City Manager, and staff negotiated the initial project costs with Georgia Power down to \$43,156.50. The contractor of the Veteran's Memorial (The Surfaces Group) has started site preparation on Wednesday, May 29, 2019. Once Georgia Power receives the required documents and payment, they will coordinate site work with the contractor.

The Under Ground Easement document requires the signature of the chief elected official of the city, the Mayor.

The "Property" is defined as that certain tract of land owned by the Undersigned at West Broad St, Sugar Hill, GA 30518 (Tax Parcel ID No. 7291 056) in Land Lot 291 of the 7 District of Gwinnett County, Georgia.

Any timber cut on the Easement Area by or for the Company shall remain the property of the owner of said timber.

The Undersigned does not convey any land, but merely grants the rights, privileges and easements hereinbefore set out.
