Sugar Hill Greenway



RECOMMENDED ACTION

Approve and authorize the Mayor to sign the Sewer Easement Encroachment Agreement with the Gwinnett Department of Water Resources for the construction, operation and maintenance of the Sugar Hill Greenway on the portion of the sewer easement between Level Creek and Whitehead Roads.

Georgia Department of Transportation (GDOT) is coordinating two uses of the old outer perimeter right-of-way between Level Creek and Whitehead Roads. The city and county have projects within one of the narrow portions of the state property. Gwinnett Department of Water Resources (DWR) is proposing improvements in the area that will affect the construction and, later the operation of the greenway trail.

The proposed solution to the conflict of uses is to allow the overlap to continue with an understanding of maintenance and repair requirements given certain contingencies. The agreement addresses situations where county activity may damage the greenway and its associated structures should they find it necessary to repair, replace, or relocate their sewer line. While this might be grounds to contest the agreement in another set of circumstances, DWR is in the position of having an existing line in place prior to trail construction.

The proposed agreement limits itself to the area shown on Exhibit A, some 300 feet of the trail, and is recommended for approval. Therefore, staff is recommending approval of the document.
