## RECOMMENDED ACTION

Recommend approval of a special use permit for a massage establishment.

### PLANNING COMMISSION PUBLIC HEARING AND RECOMMENDATION:

The Planning Commission held a scheduled public hearing on October 18, 2021. Applicant representative/owner Umang Dave spoke on behalf of this request. There were no other public comments. The public hearing was closed.

Commission Member Rosemary Walsh motioned to recommend approval of the special-use permit to operate a massage establishment as recommended by staff. Commission Member Jason Jones made second. Motion approved 5-0.

**ISSUE** 

The City of Sugar Hill has received an application dated September 3, 2021, from Umang Dave for a special use permit to operate a massage establishment under the franchise LaVida Massage.

## DISCUSSION

- The subject property is located within two vacant commercial suites in the Sugar Hill Corners shopping center where a Massage Envy franchise previously operated.
- Since the Massage Envy closed, local ordinance now requires a special use permit to operate a massage establishment.
- With a special use permit LaVida Massage is an appropriate use within the BG district.

#### FINDINGS OF FACT

Local ordinance and state law require the practice of massage therapy be conducted by individuals holding a license from the Georgia Board of Massage Therapy.

# **ZONING ANALYSIS**

1. Will the rezoning requested permit a use that is suitable in view of the use and development of adjacent and nearby property?

Yes. As the request is for a special use permit, there is no rezoning request. The proposed SUP is consistent with the development.

- 2. Will the rezoning requested adversely affect the existing use or usability of adjacent or nearby properties?

  No. The special use permit will not impact adjacent development.
- 3. Does the property for which the rezoning is requested have a reasonable economic use as currently zoned? Yes.
- 4. Will the rezoning requested create an overcrowding condition with respect to the existing streets, transportation facilities, or schools?
  - No. The proposed special use permit will not have any impact on the school system.
- 5. Does the rezoning requested conform to the Sugar Hill Land Use Plan?

  Yes. The use is in conformance with the Sugar Hill Land Use Plan.
- 6. Are there other existing or changing conditions affecting the use and development of the property which would give support to an approval or disapproval of the rezoning request?

  No. The proposed use is consistent with other similar uses located within the complex.
