 - a. Solis Sugar Hill: Mixed Use Residential, Parking & Retail project P. Radford introduced documents stating the issuing of bonds. The cost of the purchase is \$7.615 million at 2.01% Interest rate over a 12-year term; \$2.615 million will stay with DDA for buildouts. Ken commented that the document will authorize four things: 1. The issuing of the bond 2. The bank purchasing bond 3. The intergovernmental contract between the city and the DDA, agreeing that all debt services will be made through DDA to the bank 4. Authorizes the city getting a DDA agreement to develop. The target close date is 12/22 with the banks agreement to hold the rate.

Ross, 2nd by A. Jorgensen 4-0 (Unanimous)
