AX-22-001, Annexation 16.5 acres, 5768, 5778, 5788 Suwanee Dam Rd., ONRB, LLC, single-family residential RS-100/PRD, 41 single-family detached homes (Public Hearing 9-12) – Planning Director Awana stated that an updated site plan was submitted today. The lot sizes did change and the plan accommodates the greenway. A seventh condition was added that states that 10% is the maximum allowable leased houses.
