RECOMMENDED ACTION

Approve the termination of the Intergovernmental Agreement with Gwinnett County to serve as the City's certified representative and sponsor for the LCI Greenway Project.

BUDGET IMPACT

The services associated with the agreement resulted in no additional cost to the city.

DISCUSSION

The City recently received notice that the certification by GDOT for the locally-administered project (LAP) program was complete and we are ready to move forward with the LCI project as the project sponsor.

The County was instrumental in keeping the project moving forward and we are grateful to them for assistance in administering the early stages of contract administration. With the LAP approval formalized, we are ready to terminate the IGA with Gwinnett and proceed with our project independently.

Staff recommends approval of the termination document and to authorize the Mayor to sign for the City.

TERMINATION OF INTERGOVERNMENTAL AGREEMENT BETWEEN GWINNETT COUNTY AND THE CITY OF SUGAR HILL REGARDING THE SUGAR HILL GREENWAY LIVABLE CENTER INITIATIVE

This Termination Agreement (hereinafter referred to as "Agreement") made by and between the City of Sugar Hill, a municipal corporation chartered by the State of Georgia and headquartered at 5039 West Broad Street, Sugar Hill, Georgia 30518 (hereinafter referred to as "CITY") and Gwinnett County, Georgia, a political subdivision of the State of Georgia headquartered at 75 Langley Drive, Lawrenceville, Georgia 30046, (hereinafter referred to as "COUNTY") each of whom has been duly authorized to enter into this agreement.

WHEREAS, on July 6, 2022, the CITY and the COUNTY respectively approved an Intergovernmental Agreement regarding the Sugar Hill Greenway Livable Center Initiative (hereinafter referred to as "Original Agreement"); and

NOW THEREFORE, in consideration of the mutual obligations and understandings herein made, the CITY and the COUNTY agree as follows;

Pursuant to paragraph 4 of the Original Agreement entered on July 6, 2022, all the provisions of said Original Agreement shall be terminated as soon as this agreement is executed by all the parties hereto.
