- I. Call to Order 6:36 pm
- II. Approval of Agenda Motion to amend the agenda to add an item under Section VII, Action Items for Community Center / Sugar Hill Distillery by S. Nicol, 2nd by A. Jorgensen (4-0 Unanimous)
- III. Approval of Previous Meeting Minutes—Motion to approve previous meeting minutes by M. Roszel, 2nd by S. Nicol (4-0 Unanimous)
- IV. Treasurer's Report M. Roszel reported \$1,788.83 in total expenditures and \$3,510.00 in total revenue. *Motion to accept the treasurer's report by A. Jorgensen, 2nd by S. Nicol (4-0 Unanimous)*

- VI. Updates
 - a. Cadence: Mixed Use Residential and Retail (Hwy. 20 and Hillcrest Dr.) M. Neidert reported pre-leased at 92.83% and 89.76% occupied. J. Wolfe and M. Roszel had some questions about the status of leasing agent for retail space which will be followed up on next month.
 - E Center: Commercial Development, Theater, and Recreation (W. Broad St.) T.
 Besseche reported that Padley, LLC has terminated their lease and we are seeking other interests for the second-floor space.
 - c. Holbrook: Assisted Living (W. Broad St.) M. Neidert reported 50% leased, Christmas party for residents and community with 12-piece orchestra and 12/31 party from 3-6pm.
 - d. Skyview/Kittle Homes (Hillcrest) T. Besseche reported slow progress with the contractor. Next steps are to go vertical and discussed maintaining traffic control with the Authority regarding coordinating drop offs during operation.
 - e. The Local (W. Broad St.) M. Neidert reported 93.7% preleased and occupied at 92.4%. Talk of the Table is starting construction soon.
 - f. Solis Sugar Hill: Mixed Use P. Radford noted a high demand for the highway 20 corner space. Noted that a grease trap for the jewel box may be easily put in depending on the

- tenant. T. Besseche showed aerial footage of the project updates on Hillcrest, showed the parking deck entrance, and noted that top apartments will have a view of the Bowl stage.
- g. Sycamore Square/Lidl (Sycamore and Hwy 20) T. Besseche showed images of sitework underway. Lidl property will be built with parking in the rear. The current Citgo property will have interparcel access through Lidl property.
- h. Other Updates V. Richburg: Nominations for 2022 Volunteer of the Year are available.
 Mixer will be held 1/19 to celebrate all volunteers in the Waterfall Room from 12pm-2pm.

V. Richburg noted Goldmine Park opening mid-January and will signal the opening of that section of the greenway.
