## Sugar Hill Downtown Development Authority Regular Meeting Minutes

- II. Pledge of Allegiance
- III. Approval of Agenda Motion to approve the agenda by A. Jorgensen, 2<sup>nd</sup> by T. Ross (5-0 Unanimous)
- IV. Approval of Previous Meeting Minutes *Motion to approve previous meeting minutes by T. Ross, 2<sup>nd</sup> by S. Nicol (5-0 Unanimous)*
- V. Treasurer's Report T. Ross reported \$3,821.50 in expenditures and \$5,331.00 in total revenue.
  - i. Motion to accept the treasurer's report by A. Jorgensen, 2<sup>nd</sup> by S. Nicol (5-0 Unanimous)
- VI. Public Comment none
- VII. Updates
  - a. E Center: Commercial Development, Theater, and Recreation (W. Broad St.)- T. Besseche reported on E Center Plaza repairs to fountains, umbrellas, and outdoor seating. Tenants are also working on improving and maintaining outdoor seating. T. Besseche noted working with Rushing Trading Co. and Blue Land Works on lease renewals.
  - i. The Bowl Construction- T. Besseche reported on the progress of the pond flood control project which will also include amenity appearance improvements at the end of the pond. T. Besseche shared photos of what the finished project would look like. Will include tiered seating and added parking. Area provided for downtown activities such as farmers market or weddings and areas for pop-up or start up retail and restaurant spaces. Good transition space from pop-up to brick and mortar. T. Besseche noted future pedestrian bridge will not look the same as shown in image.
  - ii. Rivermill Bakery Update- T. Besseche introduced Rivermill Bakery co-owner Aleks Gerasimov to share updates. A. Gerasimov and Rivermill staff shared presentation on new menu which includes fresh made bread, European pastries, burgers, smoothie, and their own specialty roasted coffee beans. Shared excitement of being a part of Sugar Hill and community initiatives. M. Roszel expressed excitement at Rivermill being a part of the community. A. Jorgenson inquired about operating hours. A. Gerasimov noted they are open Monday-Saturday from 8am-7pm and closed Sundays.
  - b. Solis Sugar Hill: Mixed Use (Temple Dr.)- T. Besseche reported four prospective tenants have toured the downtown properties including a healthy bowl option, a lunch and breakfast option, and a possible food hall option. Solis has begun pre-leasing out of the Jewel Box. T. Besseche working with general contractors on access to Temple and Hillcrest and dismantling of Ice Rink. Working on one architectural element to parking deck structure. Commercial space will be operated by DDA. Jewel Box has temporary

- CO for leasing purposes. S. Nicol notes Jewel Box is bigger than expected. T. Besseche reported first building is expecting CO mid- Summer. M. Roszel inquired on status of parking deck. T. Besseche noted it should be open by the second Bowl concert.
- c. Cadence: Mixed Use Residential and Retail (Hwy. 20 & Hillcrest Dr.)- A. Torres reported a 91.81% occupancy rate and pre-leased units at 94.88%. S. Nicol and J. Wolfe inquired on commercial spaces. M. Roszel noted one space is leased.
- d. Holbrook: Assisted Living (W. Broad St.)- A. Torres reported a 60% occupancy rate. M. Roszel inquired on hydrotherapy pool availability to local residents. S. Nicol suggested the city working with Holbrook to get the word out.
- e. Skyview/Kittle Homes (Hillcrest)- P. Radford reported they are on the final rounds of second review for building permit. Will see site construction soon on Hillcrest. Owners of Skyview will own and operate brewpub on commercial pad. S. Nicols inquired about the price point. P. Radford answered with low-mid 800's. Website should update with floor plans soon. M. Roszel inquired about inviting owners to a DDA meeting.
- f. The Local (W. Broad St.)- A. Torres reported occupancy rate and pre-leased at 95.61%. M. Roszel noted 'Talk of the Table' hoping to open end of April and owners were at Gold Mine Park ribbon cutting and Sugar Hill birthday celebration.
- g. Sycamore Square/Lidl (Sycamore and Hwy 20)- T. Besseche reported June as target date to hand project off to Lidl project team. Possibility of old gas station becoming urgent care.
- h. Other Updates- T. Besseche showed photos of Jewel Box and The Rooftop Bar on the E Center.
  Cemetery project near completion. P. Radford noted the cemetery project is a wonderful asset to Sugar Hill's history.
