AGENDA ITEMS FOR THE COUNCIL MEETING – The meeting was called to order by Mayor Pro Tem Cohen. Also present were Council Members Alvin Hicks, Taylor Anderson, Mason Roszel and Jenn Thatcher, City Manager Paul Radford, Assistant City Manager Troy Besseche, City Clerk Jane Whittington and City Attorney Frank Hartley. Mayor Hembree was not present.

### **OLD BUSINESS**

#### **NEW BUSINESS**

**RZ-22-006, Rezoning RS-100 Medium Density Single-family Residential to R36 Medium Density Mixed Residential, 5383, 5585, 5597, 5605 & 5613 Henry Bailey Rd. (public hearing 3-13-23)** – Planning Director Awana stated that the applicant is planning on developing 78 Single-family homes, 12 detached and 66 attached townhomes. The Council discussed the price point, and whether the neighborhood will be gated. They also discussed the safety of the closest media cut on Highway 20 being at Arbor Close. The applicant should consider having the entrance and exit on Henry Bailey instead. The Plannning Director was asked to go over the townhome developments that have been approved whether developed or in progress.

**RZ-22-007, Rezoning RS-100 Medium Density Single-family Residential to BG General Business, 5422 Sugar Ridge Drive, (public hearing 3-13-23)** – Planning Director explained that this rezoning application is for a commercial development at the corner of Sugar Ridge Drive and Highway 20. The applicant proposes retail office and a restaurant. Some residents expressed concerns regarding safety of the Sugar Ridge since it is residential. There were discussions from the Council regarding the restaurant and the proposed use of septic instead of sewer. Also concerns regarding the pedestrian access next to Highway 20 instead of being offset backed away from Highway 20. The public hearing will be held at the March 13<sup>th</sup> Council Meeting

**Nuisance Ordinance Amendment** – Planning Director explained that this ordinance will assist code enforcement with addressing issues related to nuisances within properties in the city.

#### GDOT Widening Project #0015439, GDOT Utility Agreement, Natural Gas Main

**Relocation** – Assistant City Manager City Manager Besseche explained that the city's natural gas distribution mains are in the portion of the Highway 20 widening project. The relocation agreement is necessary to complete the preconstruction phase of the widening that extends from Peachtree Industrial Blvd. to Buford Highway. The work has been designed ty the city's consultant and will be ready to start later in 2023. Staff is recommending approval with the city's cost (\$151,763.50) to be funded from the gas department reserve funds.
