Please inform all concerned that the Request is modified by this Addendum.

CLARIFICATION:

Bids are still due at the Sugar Hill City Hall <u>Customer Service Desk in the main lobby BEFORE 2:00PM January</u>

18, 2024 local, legal time. Bids will be opened in the Community Room at 2:05 P.M. and read aloud.

QUESTIONS:

- 1. Can MH & Valve Adjustments be completed using adjustable rings? A: Yes. Submittals required for approval, but no proprietary products have been specified.
- 2. Pay item 7 calls for a 6" width milling. Was it meant to be 6'? If not, could you please confirm or verify which is the correct width? A: 72-inches or 6-FT is the correct width.
- 3. Section J.1 Asphaltic-Rubber Crack Fill calls for the crack seal to be performed prior to the resurfacing. Can you please clarify if this work is to be performed before or after the edge milling? **A: Perform after edge milling.**
- 4. Can the city provide a project location, for estimating purposes only, where the GAB will be placed? **A: Not at this** time. **GAB may be placed as needed for deep patches as identified during pre-construction review.**
