### RECOMMENDED ACTION

Award the Construction Contract to Garrett Paving Company for the Road Resurfacing and Repair project in the amount of \$541,870.

## **BUDGET IMPACT**

The funds for this project are available from the SPLOST Transportation category as well as from GDOT 2024 Local Maintenance and Improvement Grant program (LMIG) with the balance being funded from general funds sourced from property tax receipts. The 2024 Capital Improvement Budget anticipates using these funds for this project and it is under budget (\$650,000).

#### **DISCUSSION**

Bid documents for the project were drafted in-house with assistance from our project management team and advertised in December. Ads were placed in the legal organ twice, in accordance with state contracting law for road projects, while the contracting opportunity was published on our website and the Georgia Procurement Registry continuously during the bid period. Eighteen (18) prospective contractors picked up bid documents while one plan room helped advertise the opportunity.


Bids were received on January 25, meeting the advertising regulations in place for this type of project. Ten (10) bids were received (up from 8 last year):



After reviewing the bids submitted and verifying the calculations on each pay item, staff determined the apparent low bidder to be Garrett Paving, Inc. After confirmation of their qualifications and pay items, staff is ready to recommend award of the construction contract for the 2024 Road Resurfacing and Repairs (LMIG) to Garrett Paving in the amount of \$541,870.49.
