WHEREAS, Marc was very involved in the Georgia Municipal Association where he served multiple terms as President of District 3 NE and representative to the University of Georgia Municipal Training Board; and

WHEREAS, Marc serves as Chair of the Gwinnett County Police Citizen Advisory Board; Sr Vice Commander of the Sons of the American Legion Post 127; a Merit Badge Counselor for the Boy Scouts of America, member of both the North Gwinnett High School and North Gwinnett Middle School Councils; and Scholarship Chair of the Gwinnett Student Hockey League; and served in leadership roles for the NGHS Marketing/DECA Advisory Board; Artworks Gwinnett, and the North Gwinnett Schools Foundation; and

WHEREAS, Marc is a 2018 graduate of Leadership Gwinnett where he continues to serve as a Study Group Facilitator and Board Co-Chair; and

WHEREAS, Marc has received a variety of awards and recognitions for government service including the University of Georgia, Carl Vinson Institute of Government Certificate of Recognition, Certificate of Achievement, Certificate of Excellence, Certificate of Distinction, Certificate of Dedication and the Knox Municipal Leadership Institute; and

WHEREAS, Marc is a marketing and operations professional who has a passion for community involvement. He earned a BA in Economics/Business from the University of California at Los Angeles and an MBA from San Francico State University. He and his wife Marie are very involved in the community where they live, and their two children have grown up.
