2025 Roadway Repair & Resurfacing

#### RECOMMENDED ACTION


1. Authorize the Mayor to sign and submit the application for the 2<sup>nd</sup> round of 2025 Georgia Department of Transportation (GDOT) Local Road Assistance Program (LRA) program for improvements to the proposed list provided in the staff memo.

- 2. Authorize the Mayor to approve a contract amendment with Triple R Paving for the additional streets up to a contract total of \$ 1,500,000.
- 3. Approve attached budget amendment to the CIP recognizing the additional state funds.

#### BUDGET IMPACT

The project budget for 2025 is \$1,000,000. A contract with Triple R Paving was awarded earlier this year in the amount of \$862,860. Additional funds from the state through the Local Road Assistance program (LRA) will allow an additional \$309,170.92 to be added to the program with no (additional) local match requirement. The budget will be amended to reflect the additional funds (LRA and SPLOST) for expenditures up to \$1,500,000 to accommodate new mobilization and final quantity adjustments.


## **BACKGROUND**

### **DISCUSSION**

In February 2025, the city council approved for submittal under the GDOT grant program fifteen (15) streets as a part of the original FY25 state funding program. Since that time, the state has authorized additional funding for this fiscal year for Sugar Hill in the amount of \$309,170.92 from the Local Road Assistance source under the LMIG program. No local match is required for the new funds.

Staff looked at options to tackle pavement preservation methods, but for efficiency's sake is proposing adding the next set of streets for the same repair methods currently in the Triple R contract. The proposed streets were based on roadway score & location; having taken them from the September 2024 pavement condition assessment. The streets are listed with the corresponding lengths, cost based on the unit prices from recent bids, and pavement rating. These represent an addition of some 53% to the original scope length (3.05 plus 1.62) resulting in an annual total of 4.67 miles. Staff recommend approval of these additional, eight (8) streets be added to the grant application for the second round of funding:
