NEW BUSINESS

- **a.** Suite Spot Mural Number 2
 - **a.** Chris Walker came in and presented his 5 part mural idea for the side of the Suite Spot Business Incubator to the group. The group enjoyed the aesthetics of the mural. Chris Walker mentioned that the Suite Spot Business incubator logo may change, and that the first panel would be modified to create a more diverse depiction of Sugar Hill. Terence Mulligan noted that the work lent itself to the community. This mural will be crowd-funded unlike the initial mural. Chris Walker said he would need about 50% of the funds, \$10K, to begin the mural process. This would include pressure washing the entire wall, priming, and prepping, as well as the initial cost of materials. This would also include the preliminary outline of the entire mural, so as to generate interest and enthusiasm and attract additional funders. There was talk about how we obtain this initial funding. Some ideas included finding sponsors, receiving funding from the developer, and crowd funding. John Lane mentioned crowd-funding and locating businesses to provide matching gifts. Marc Cohen said he would follow up with Scott Andrews and Paul Radford to determine if they had developed a plan on how to acquire initial funding yet.

At this time Member Marc Cohen exited the meeting.

 - **a.** John Lane will deliver paint to Nicole Klein on 3/24/2017 and she will paint the piano the following week.
- **d.** Artist of the Month
 - **a.** Georgia Council for the Arts Shaping the Future of the Arts in Georgia April 10th.
 - **a.** May be good for brainstorming
 - b. Information for the Artist of the Month has been passed along to the North Gwinnett Arts Association. There is a meeting with them on 3/27/2017 to discuss displaying art in the Suite Spot. Dororthy Duckworth-Floyd requested to be involved in this meeting as she currently occupies the Suite Spot.

NEW BUSINESS

- **b.** Sugar Rush
 - **a.** The Arts Commission feels strongly about returning to a juried show this year and simply improving signage for the event. It provides a nice indoor break for festival goers to get out of the elements and eliminates the threat of the elements for the Commission. It allows the Commission to promote the City Art Gallery, Artist of the Month Applications, and encourage sign-up for news and events related to the Arts Commission.
 - **b.** An application fee vs. acceptance fee was discussed. It will be free to apply, but once accepted, the fee will be \$35.
 - c. Work can be posted for sale depending on the artists preference.
 - **d.** Kerry Murphy will work on an application and have it by next week.
 - **1.** That application will call for a July 15th deadline to submit.
 - **2.** The application will be advertised on multiple websites and potential magazines.
 - a. Burnaway
 - **b.** Chris Walker mentioned Zapp, will send details.
 - e. All present members of the Arts Commission felt strongly about providing a substantial prize for the selected winners of the juried exhibition.
 - **1.** Prizes of \$1000 for first, \$500 for second, and \$250 for third were supported.

- **3.** Dorothy will reach out to the Rec. Department and see if they can put the Arts Commission in touch with anyone who has taught arts related classes at the Community Center in the past.
- **4.** Additional discussion centered around the ability for the Arts Commission to partner with local businesses to use their locations for events
