Work Session Issues for Council Meeting – Present were Mayor Gary Pirkle, Mayor Pro Tem Curtis Northrup, Council Members Marc Cohen, and Mike Sullivan. Council Members Edwards and Gajewski were not present. Also present were City Manager Bob Hail, City Clerk Jane Whittington and City Attorney Frank Hartley.

AX-12-001, David Horne, 492 Riverside Rd., .56 Acres, R-100 to BG – Dir. Awana explained the variance request. The applicant is requesting a BG zoning and wants a variance on the sidewalks both on Riverside Rd. and Suwanee Dam Rd.

VAR-12-001, Amerigas, 4823 Lanier Ave. – Dir. Awana explained the application. The Amerigas facility is located within the Town Center Overlay. The City Attorney stated that they have a nonconforming use and would have to rezone the property to expand. The current zoning HM1 and would need to be HM2. Charles Sims spoke for the applicant. They are planning to move their Regional Marketing Manager to this facility and expand the offices to accommodate this move. This would be 24' X 24' and would house the Local Manager, Marketing Manager and a large conference room. They are requesting a variance on the curb and gutter to allow heavy trucks to be in the facility. Their main concern was the cost of the sidewalk. The Mayor explained that they would need to apply for a rezoning and include their requested variances in it.

CBD – Design Review Board, Bridgett Jorgensen, 4955 Alton Tucker Blvd. –

Dir. Awana explained that the Jorgensen's are requesting to renovate their property at 4955 Alton Tucker Blvd. This includes above the windows, doors and a monument sign. All the work is cosmetic and would include keystone above the windows.

Resolution 2010 CDBG, Pass Ct. & Hessie Ln. – The City Manager explained that this resolution completes the documentation with Gwinnett County regarding the sidewalks and drainage for Pass Court and Hessie Lane. Mayor and Council requested that this be put on the Consent Agenda.

GEMA Agreement – The City Manager explained that this is an update to an agreement that has been in place since he has been with the City. It is a joint agreement wit Gwinnett County for Emergency Management.
