Resolution Natural Gas Hedging – the City Manager hedges natural gas purchases for the best pricing for the City's customers. The Municipal Gas Authority needs a resolution allowing the City Manager to purchase gas or hedge on behalf of the City. The Council agreed that the Resolution should include that if the hedging was for more than three years out then the Mayor and Council must be notified.

Ordinance – Retail Business Window Visibility – the Planning Director drafted this ordinance under the direction of the City Manager because of safety issues and prevention. More time was needed to review this ordinance and its effect on businesses.

Adopt Gwinnett County Ordinance Regarding Applicant Background Reviews & Employee Work Permits – The City Clerk had a situation come up regarding an appeal to the background permit for a locksmith. The City does not have an appeal board in their ordinance for locksmiths, taxi cabs and businesses of this type. More time to review the ordinances is needed. The City Clerk and City Attorney are to work together to review the ordinances and recommend how the appeals are handled.

Recreation Updates – The City Manager updated the Mayor and Council on the recreation events that are upcoming. The Easter Egg Hunt and Touch a Truck are the next events.

City Hall Updates – Pictures were shown of the City Hall, amenity pond and West Broad construction.
