- 1. Resolution Creating Arts Commission** – Mayor Pro Tem Member Cohen explained that the Arts Council will be an advisory board to oversee the arts within the City. They will help with music for the festivals, film series, performing arts and any other type of art. It was suggested that the terms be staggered to prevent a possibility of an all new board on appointment.
- 2. Broad Street Band Agreement** – Assistant City Manager Troy Besseche explained that this agreement lays out the events and free concerts the band will participate in. The City will sponsor a facility for the band to rehearse in for participation in these events and concerts.
- 3. Third Quarter Budget Amendment** – The Assistant City Manager explained that this amendment is for interdepartmental transfers. It could possibly be tabled if all the figures cannot be compiled before the Council Meeting.
- 4. Plaza Security Contract Renewal** – **The** Assistant City Manager explained that there would be a slight increase in the rates per hour. This increase is minimal and staff recommends approval of this contract.
- 5. Sugar Hill Youth Council** – Council Member Sullivan introduced the Youth Council members that are up for nomination by the City Council. The Mayor and Council then introduced themselves and explained how the Work Sessions and Council Meetings are ran. The members will be present at the Council Meeting for nominations and administering of the oath.
