OLD BUSINESS

Housing Study – Planning Director Awana explained that this study is a summary of the demographics with a five year plan showing trends. The gap in housing is for low or moderately low income housing. He is requesting to table until the March meeting to allow more time to promote the study.

NEW BUSINESS

RZ-15-011, Rezoning/Special Use Permit/Town Center Overlay Design Review Approval, Mahaffey Pickens Tucker, LLP, Request to Rezone to HSB with a Special Use Permit to allow building material sales with outdoor storage for granite stone countertop shop and retail business. Also seeking Town Center Overlay Design Review approval DRB-TCO-15-01719 (Public Hearing at 2/8/16 Council Meeting) – Director Awana explained that the Planning Commission recommended approval to store large slabs of granite and like materials outside.

Proclamation Recognizing the 60th Anniversary of the Georgia City-County Management Association – the City Manager explained that the Association requested that the cities and counties pass this proclamation in honor of their 60th Anniversary.

CITY MANAGER DISCUSSIONS/UPDATES

EpiCenter Update – the funding is progressing with the interest in bank financing underwriting of the market bonds. The sign will be installed stating coming soon.

Downtown Development Project Update – the DDA will hold a Special Called Meeting on February 11th at 4:30 at City Hall.

Racetrac has a new engineer and will be closing on the property soon.

Macauley group will meet again on February 9th to look at the next iteration of the project. They are looking at four stories with underground parking.

Sugar Loop Greenway – the city is looking at hiring a consultant (Jacobs Consultant) to complete a ten year master plan for the Sugar Loop.

Construction Update – Assistant City Manager gave an update on the bowl and other construction projects.
