**APPROVAL OF AGENDA** – Mayor Pro Tem Northrup motioned to amend and approve the agenda by tabling item #3, RZ-16-008. Council Member Sullivan seconded the motion. Approved 5-0.

**Final Plat Ratification, Primrose Creek Unit 2B** – Mayor Pro Tem Northrup motioned to table this item until next month. Council Member Sullivan seconded the motion. Approved 5-0.

**Public Hearing, RZ-16-008, Property Solutions Group, LLC, Buford Hwy 23, re-zone from HM-1 to RS-100/PRD – TABLED**

**Public Hearing, AX-17-001, Re-zone OI, 5494 Cumming Highway, Tax Parcel 7-321-016 –**

Director Awana explained that the OI would be a good zoning for a park. The City plans to use this as greenspace and will be holding a charrette to design it. The public hearing was opened and Angie Lamb whose grandparents originally owned the land spoke regarding her family and how the land was obtained. The family prefers that this become a passive park. It is residential all around and they are concerned with noise and light. There were no other comments so the hearing was closed. Council Member Sullivan motioned to approve the annexation (AZ-17-001) and rezone the property OI. Council Member Gajewski seconded the motion. Approved 5-0.

**Planning Commission Appointment** – Council Member Sullivan nominated Phil Olsen. There were no other nominations so the Mayor administered the oath to Mr. Olsen.

**Arts Commission Update** – Council Member Cohen nominated Dorothy Floyed. There were no other nominations so she will serve on the commission.

**Resolution Building Authority** – the City Attorney explained that this resolution will authorize a Sugar Hill Building Authority Act to be passed by the Georgia Legislature. This will create a building authority that will assist the city in building, managing and operating its projects. It will consist of 7 members with staggered terms. The Mayor and Council can serve on the authority. The proper ads will run and then it will go to the Georgia General Assembly. Council Member Cohen motioned to approve the Resolution of the governing authority of the City of Sugar Hill regarding the creation of the Sugar Hill Building Authority and to approve the proposed legislation to go before the Georgia General Assembly for approval. Mayor Pro Tem Northrup seconded the motion. Approved 5-0

**EXECUTIVE SESSION: TO DISCUSS LEGAL, REAL ESTATE AND/OR PERSONNEL –**

Council Member Sullivan motioned to enter Executive Session. Council Member Cohen seconded the motion.

**PUBLIC ACTION TAKEN OUT OF EXECUTIVE SESSION** – Council Member Hembree motioned to approve the First Amendment to Purchase and Sale Agreement for the Iconic project between the City of Sugar Hill and the Sugar Hill Downtown Development Authority. Council Member Cohen seconded the motion. Approved 5-0.

**ADJOURNMENT** – Council Member Gajewski motioned to adjourn. Council Member Sullivan seconded the motion. Approved 5-0.
