AGENDA ITEMS FOR THE COUNCIL MEETING - Present were Mayor Steve Edwards, Mayor Pro Tem Curtis Northrup, Council Members Marc Cohen, Brandon Hembree, Susie Gajewski and Mike Sullivan. AWARDS AND PRESENTATIONS/PROCLAMATIONS -

Proclamations –**Teachers of the Year North Gwinnett Cluster** – Council Member Cohen explained that every year the Mayor and Council honor the Teacher of the year from both school clusters at the November and December Council Meetings. Each teacher will receive a proclamation and their principals are invited.

OLD BUSINESS

Zoning Ordinance Amendment Article 4, 9 & 10 – Planning Director Awana explained that the changes have to do with lot coverage and density standard. Tattoo as a special use in HM1 has been changed to GB. With a special use the conditions goes away with the owner. Council Member Northrup would like more discussion on this special use provision in GB.

NEW BUSINESS

Project Update – Highway 20 Corridor Study & LCI Downtown Master Plan Update – Planning Director Awana explained that there will be meetings in November for the public and then adoption at the December Council Meeting.

Historic Preservation Society Ordinance Amendment – Council Member Hembree explained that the members would increase from 7 members to 11. The amendment adds a treasurer that can be someone other than a member of the board.

Historic Preservation Society Appointments – Council Member Hembree explained that he will be recommending 3 new appointments for the Council Meeting.

Arts Commission Appointment – Council Member Cohen will recommend a new member for appointment at the Council Meeting

2018 Proposed Operating and Capital Improvement Budget (Public Hearings to be held 11/13/17 and 12/11/17) – the City Manager Paul Radford explained the proposed budget and 2017 year in review. Assistant City Manager Besseche explained the proposed Capital Improvement Budget. The 1st public hearing will be held at the November 13th Council Meeting.

Events Evaluation – Mayor Edwards asked the Council to look at the events and the caliber of each event and consider tweaking some of them. Some of the events could be combined or modified.

Council Member Sullivan requested that the videos of the Council Meetings be put on the website. There were questions regarding archival, what do cities around us do. The Council requested that more research be done before considering this.
