Collection bins will be located in the lobby at City Hall for easy access. When you drop by the new Post Office located in City Hall or when you pay your gas bill, bring the items with you. We will also be accepting unwrapped toys for the Co-Op. All of these items will go to the less fortunate in this area. We will deliver the food items both at Thanksgiving and Christmas; at Christmas we will also deliver the toys.

The City is sponsoring something new this year called the Mayor's Motorcade. The Cities around the Atlanta area collect items for the

Georgia Mental Health Facility located in Atlanta. These people are often forgotten during the Holiday Season. The City Officials deliver these items and participate in a parade and celebration for the patients. These items should be new, unwrapped and delivered to City Hall. All of the patients are adults or teens; therefore, they need everything from house slippers to toiletries and games. They also accept donations (checks should be made out to the Georgia Regional Hospital Atlanta). Gift wrap, ribbons and bows are also needed. BUSINESS LICENSE/OCCUPATION TAX RENEWALS COMING SOON

All businesses located in the City of Sugar Hill, your **business licenses will expire on January 31, 2005**. The gross receipts must be filed with the City Clerk's office so the Occupation Tax can be calculated. Applications for renewal will be sent in December. It is crucial for all businesses to make any changes on the application and to fill in the portion requesting gross receipts or the number of professionals and mail this back to the City. Invoices will then be generated and mailed. The licenses will be mailed upon receipt of payment.
