Construction Watch: New and Ongoing



Construction continues at Gary Pirkle Park with the playground pavilion now sporting a roof and flagstone trim. The walking trail is completely paved and trail lighting is nearing completion. At the Sugar Hill Golf Course several improvements are underway. Pictured is a gazebo under construction offering a seating area with great views.

News Bites:

- Sedimentation from stormwater run-off on construction sites is a major contributor of pollution to our streams and lakes. The City of Sugar Hill has Georgia Soil and Water Conservation Commission (GaSWCC) certified inspectors who routinely visit permitted sites for violations to the Soil Erosion and Sedimentation Control Ordinance. The inspectors check for the proper installation and maintenance of erosion control measures, such as: construction exits, silt fences, check dams, erosion control blankets, sediment traps, etc... Help protect our streams and drinking water. If you notice an erosion problem (muddy streets or streams, construction activity within 50 feet of a stream, working without a permit, etc ...) please contact the Planning and Development Department and let us know. Reporting a potential violation is easy, visit our website at: www.cityofsugarhill.com and fill out a **Sugar Hill C.A.R.E.S.** form or call us at 770-945-6734.
- The Susan G. Komen 3 Day Walk For The Cure made a rest stop in Sugar Hill's Town Green. The City welcomed the visit from 2100 walkers making the 60 mile route from Lake Lanier Islands to Turner Field. Refreshment and medical booths and plenty of porta potties were set up for the walkers.
- After several delays dealing with Georgia DOT, the Kroger Super Store is underway at the corner of Hwy 20 and Suwannee Dam Road. Final building and construction plans are under review in our Planning Dept. but the grading permit has been issued for work on the property.
- The Sugar Hill Downtown Development Authority launched a new Sugar Hill Business Alliance at the Sugar Hill Diner. A large turnout filled the meeting room as business owners networked, sampled appetizers, and heard from Dawn Gober DDA Chair, and Bridgett Jorgensen DDA secretary and organizer for the successful first meeting.
