## Changing of the Guard in Sugar Hill!

An era is ending and a new chapter begins in Sugar Hill. After 12 years serving as Mayor of Sugar Hill, - Gary Pirkle decided to step down at the end of December and will hand off the reigns to the recently elected, Steve Edwards. Mayor Pirkle has served the City as a Councilman from 1997 till 2001 when he ran for and was elected Mayor. During his tenure as Mayor, along with retiring City Manager Bob Hail, they brought prosperity and financial stability to our City by carefully managing the City finances and the annual budget. As a result of their stewardship the City has been able to build new and expanded parks, a new City Hall, West Broad Street streetscape, an amphitheater and a bright future for the City. Our citizens have enjoyed a stable millage rate for the past 13 years. All of this has been accomplished without raising taxes, floating bonds, or borrowing. National publications have rated Sugar Hill as one of the best cities for young families, one of the fastest growing cities and having a top rated golf course. Incoming Mayor Steve Edwards served as a Councilman for 8 years and ran unopposed for Mayor. DDA member Brandon Hembree was elected to fill the remaining City Council seat of Mayor Edwards.


