## The City of Sugar Hill Plaza Security Patrol Actions Apr.19th, 2016 – Apr.25th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 04-19-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. While working on the weekly report the Officer received a cell call from the Big Lots. The Complainant advised that two subjects were on location and acting in a suspicious manner. The Officer advised that he would be en-route and be there in a matter of minutes .Upon his arrival at the Big Lots, located in the Sugar Hill Station shopping center he was advised that a w/m and w/f had been roaming the store and would fill a shopping cart and then leave, only to return and preform the same actions. The Officer stated that he would place the subjects under surveillance and watch for suspicious activity. The suspicious couple was in the store for approximately 45 minutes with the Officer maintaining surveillance. The subjects then went to the check out and paid for the items in the second shopping cart and declined to purchase the items in the first shopping cart. The couple then left without incident. The Manager declined action since no apparent crime was committed. No other incidents were observed by or reported to security personnel.
- 04-20-16-Officer made routine patrols of both residential and business properties. This also
  included, but was not limited to the P.O.A.P. While checking the area of the E, E, Robinson Park
  located a suspicious vehicle. The vehicle appeared abandoned with a hand written note on the
  dash advising that the clutch had gone out and it would be towed ASAP. Later in the shift while
  insuring that the Shell clerk made it to his vehicle after closing the Officer encountered a subject.
  When requested to depart the area due to the businesses being closed for the night the subject
  became belligerent. After a brief exchange of un-niceties the subject exited the property without
  further incident. No other incidents or issues were observed by or reported to security personnel.
- 04-21-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. The Officer while closing the E.E. Robinson Park encountered a couple parking. The Officer advised that was not the appropriate location for that sort of activity and to move on. The subjects did so without incident. No other issues or incidents were observed by or reported to security personnel.
- 04-22-16- Officer while on patrol made multiple area checks in the city parks. The Officer made routine patrols of both residential and business properties, including P.O.A.Ps. No incidents were observed by or reported to security personnel.
- 04-23-16-Officer preformed routine patrols of both residential and business properties. The patrol
  included but was not limited to P.O.A.P.'s. No incidents or issues were observed by or reported
  to security personnel
- 04-24-16-The Officer made routine patrols of both business and residential properties for suspicious or illegal activities. No issues were observed by or reported to security personnel
- 04-25-16- The Officer performed routine patrols of both business and residential properties with no incidents to report. No incidents were observed by or reported to Plaza Security L.L.C. personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road. Patrols also cover all other subdivisions.
