

The City of Sugar Hill
Plaza Security Patrol Actions
May 17th, 2016 – May 23rd, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 05-17-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. No incidents were observed by or reported to security personnel.
- 05-18-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P. While on patrol the Officer received a call from Ms. Shafer in reference to a noise complaint. Ms. Shafer advised the Officer that the incident location was in Gary Pirkle Park. The Officer responded to the incident location and advised the subjects to turn down the music. This request was carried out without incident. The Officer returned to service. No other incidents or issues were observed by or reported to security personnel.
- 05-19-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 05-20-16- Officer while on patrol made multiple area checks in the city parks. The Officer made routine patrols of both residential and business properties, including P.O.A.P.s. No incidents were observed by or reported to security personnel.
- 05-21-16-Officer performed routine patrols of both residential and business properties. The patrol included but was not limited to P.O.A.P.'s. The Post Supervisor received a text from the Assistant City Manager regarding a Black Bear being observed in the area of The Arbor Clos Subdivision. The Supervisor confirmed this information with Gwinnett Animal Control. He was advised that they had tried, without success to capture the Bear but that it had eluded them. The Animal Control Officer advised that the situation regarding the Bear was being turned over to the Department of Natural Resources for further action. No incidents or issues were observed by or reported to security personnel
- 05-22-16-The Officer made routine patrols of both business and residential properties for suspicious or illegal activities. No issues were observed by or reported to security personnel
- 05-23-16- The Officer performed routine patrols of both business and residential properties with no incidents to report. No incidents were observed by or reported to Plaza Security L.L.C. personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road. Patrols also cover all other subdivisions.
