

The City of Sugar Hill
Plaza Security Patrol Actions
May 24th, 2016 – May 30th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 05-24-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. The Officer met with Code Enforcement Officer McDaniel in reference to an ongoing violation in the Sugar Crossing Subdivision. C.E.O. McDaniel's requested patrols after 1900 hours to see if a noise violation was occurring between 1900 -2300 hours. The Officer advised he would make periodic checks through the week, and report his findings. No other incidents were observed by or reported to security personnel.
- 05-25-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P. While on patrol the Officer received a call from City Hall in reference to skateboarders at the Gazebo. Upon his arrival the Officer was unable to locate the skateboarders of who had left prior to his arrival. The Officer went back in service. No other incidents or issues were observed by or reported to security personnel.
- 05-26-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 05-27-16- Officer while on patrol made multiple area checks in the city parks. The Officer made routine patrols of both residential and business properties, including P.O.A.Ps. While securing the upper portion of Gary Pirkle Park, near the Suwanee Dam Road entrance, the Officer observed a vehicle parked. The Officer checked the vehicle of which was unoccupied. The Officer continued to secure this portion of the Park and went to the lower portion and had secured it when a male subject came running up. The male subject stated that he was unaware that the park was closed and requested to get his vehicle out. The Officer advised the subject that there are numerous signage warning visitors of the parks operating hours and what can happen if a vehicle was left. The Officer then advised the subject to meet him at the upper portion and he would unlock the gate permitting him to get his vehicle. The Officer opened the gate and permitted the subject to leave without incident. No other incidents were observed by or reported to security personnel.
- 05-28-16-Officer preformed routine patrols of both residential and business properties. The patrol included but was not limited to P.O.A.P.'s. The Officer received a call at 2200 hours that a person/s was discharging fireworks in the Suwanee Dam Road area of Gary Pirkle Park in the park. The Officer made a thorough search of the area and had negative contact with the perpetrators. The Officer then went back in service. No other incidents or issues were observed by or reported to security personnel
- 05-29-16-The Officer made routine patrols of both business and residential properties for suspicious or illegal activities. No issues were observed by or reported to security personnel
- 05-30-16- The Officer performed routine patrols of both business and residential properties with no incidents to report. The Officer at 1805 hours received a call from Lt. Tate Plaza Security, LLC in reference to a complaint of code violations. These were but not limited to oversized trucks parked in his driveway, in the street and on his lawn. The Officer obtained photographic evidence of the violation and forwarded it to Sugar Hill Code Enforcement for further investigation and /or prosecution. No other incidents were observed by or reported to Plaza Security L.L.C. personnel.

- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road. Patrols also cover all other subdivisions.
