

The City of Sugar Hill  
Plaza Security Patrol Actions  
Jul.12th, 2016 – Jul.18th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 07-12-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. The Officer met with Officer McDaniel, Sugar Hill Code Enforcement in reference to an abandoned car in the Princeton Oaks Subdivision. Officer McDaniel advised that a vehicle was parked in the cul-de-sac, on Winslow Court with a tarp on it and appeared to unregistered and wrecked. The Officer went to Winslow Court and made contact with the vehicle. The Officer checked for a tag and was unable to locate one. The Officer then contacted GCPD Dispatch and requested a unit be en-route to check the status of the vehicle. Upon the GCPD Officer's arrival he checked the vehicle via NCIC and GCIC for registration through Georgia. The vehicle returned not on file so he checked the other 49 states. The vehicle returned with an expired tag through the State of New York and valid through the State of Florida. The Officer put a GCPD tow tag on the vehicle giving the owner 5 days to remove vehicle or it would be impounded. At about 23:10 hours while trying to lock the gates a GCPD Officer arrived and inquired if the Plaza Officer had observed a suspicious white male and female in the Gary Pirkle Park area. The Plaza Officer allowed the GCPD Officer to check the parking lot since he had superior illumination equipment then the Plaza Security Officer's. At about that time a second GCPD Officer arrived and was allowed in. After a few minutes a white male and female were observed walking from the rear of the park. The Plaza Officer challenged them and they advised that the GCPD Officers had already questioned and released them. All units went back in service. At 00:36 the Officer ran off 6 suspicious subjects hanging around City Hall. As it turned out they were Poke' Mon gamers. No other incidents were observed by or reported to security personnel.
- 07-13-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. No incidents or issues were observed by or reported to security personnel.
- 07-14-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. The Officer while en-route to the community center observed 10 suspicious persons roaming around the downtown area. Upon making contact with the subjects the Officer was advised that they were playing Poke' Mon. The Officer advised them to be safe and not enter onto private property. No other issues or incidents were observed by or reported to security personnel.
- 07-15-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security personnel.
- 07-16-16- Officer while on patrol made multiple area checks in the city park for suspicious and/ or illegal activities/s. The Officer made routine patrols of both residential and business properties, including P.O.A.Ps. No incidents were observed by or reported to security personnel.
- 07-17-16- The Officer performed routine patrols of both business and residential properties including, but neglecting P.O.A.P.'s. The Officer while on patrol was flagged down by a resident of the Abingdon Subdivision in reference to criminal damage done to the swimming pool. The resident went on to advice that two possibly teenage boys had climbed the security fence around the pool and while illegally in the interior of the pool area had broken beer bottles. The resident was unable to provide any other information on the suspects. No other incidents were observed by or reported to Plaza Security L.L.C. personnel.
- 07-18-16- The Officer made routine patrols of both residential and business properties not neglecting the P.O.A.P.'s. No incidents were observed by or reported to security personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road. Patrols also cover all other subdivisions.
