

The City of Sugar Hill  
Plaza Security Patrol Actions  
Sept.05,2016 – Sept11th,2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 09-05-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. The Officer while locking the Austin Garner Road entrance to Gary Pirkle Park positioned his patrol vehicle diagonally across the drive after ensuring that that no one was in the park's rear parking area. The Officer then checked and locked the restrooms. Upon returning to his patrol vehicle he heard voices and upon reaching the drive observed a vehicle had been driven around his patrol car and three subjects were walking towards him. The Officer sternly advised that the park was closed. The adult in the group advised that her daughter had left her Yeti cup at soccer practice and could they please look for it. The Officer advised that they could. After a few minutes the subjects returned without the cup. The Mother advised the Officer that maybe one of her team mates picked it up. The subjects exited the park and the Officer locked the gates. No other incidents were observed by or reported to security personnel.
- 09-06-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. The Officer checked the Highland Dr. area for suspicious activity, but had negative contact with anyone. No incidents or issues were observed by or reported to security personnel.
- 09-07-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 09-08-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. The Officer while on patrol in The Abington Subdivision encountered a resident who stated that a vehicle was abandoned at the pool area for three weeks. She then advised the Officer that she would contact the GCPD in reference to having it towed the next day. The Officer then returned to service with no action taken. No other issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 09-09-16- Officer while on patrol made multiple area checks of the city park for suspicious and/ or illegal activity/s. The Officer also made routine patrols of both residential and business properties, including P.O.A.Ps. No incidents were observed by or reported to security.
- 09-10-16- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. This did not exclude the P.O.A.P's listed. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 09-11-16- The Officer made routine patrols of both business and residential properties including the P.O.A.P.'s for suspicious and/or illegal activity/s. During the Officer's tour of duty no incidents were observed by or reported to Plaza Security LLC personnel.

- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park. Patrols also cover all other subdivisions.
