

The City of Sugar Hill  
Plaza Security Patrol Actions  
Sept.12th, 2016 – Sept18th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 09-12-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. The Officer while on patrol in the Twin Creeks subdivision observed three suspicious subjects. From the Officer's observation it was apparent that the subjects were soliciting. When the Officer made contact with the subjects he inquired if they had a soliciting permit. The subjects responded that they did not. The Officer then advised the subjects to leave the area before they were cited by GCPD for soliciting without a permit. The subjects left without incident. No other incidents were observed by or reported to security personnel.
- 09-13-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. The Officer made extra extended patrols of the Splash Pad. No incidents or issues were observed by or reported to security personnel.
- 09-14-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 09-15-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 09-16-16- Officer while on patrol made multiple area checks of the city park for suspicious and/ or illegal activity/s. The Officer also made routine patrols of both residential and business properties, including P.O.A.Ps. No incidents were observed by or reported to security.
- 09-17-16- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. This did not exclude the P.O.A.P's listed. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 09-18-16- The Officer made routine patrols of both business and residential properties including the P.O.A.P.'s for suspicious and/or illegal activity/s. During the Officer's tour of duty no incidents were observed by or reported to Plaza Security LLC personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park. Patrols also cover all other subdivisions.
