

The City of Sugar Hill
Plaza Security Patrol Actions
Oct.3rd, 2016 – Oct.09nd, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity reported to them also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 10-03-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious activity. No incidents were observed by or reported to security personnel.
- 10-04-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. The Officer while on routine patrol observed a suspicious person in the Fairview Park Subdivision. Due to extensive encounters with similar individuals the Officer believed that the subject was soliciting. The Officer proceeded to make contact with the subject and his presumptions were verified that the subject was indeed a solicitor. The Officer advised the subject that he was on private property and was subject to arrest by GCPD if did not leave. The subject left without incident after being given this information. Director Frassrand, Plaza Security LLC, contacted the Officer via cell phone in reference to illegal parking in The Arbors Clos Subdivision. The Officer made a thorough check of the area and found no such violations. The Officer then went back in service, after advising Director Frassrand of his findings. No other incidents or issues were observed by or reported to security personnel.
- 10-05-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 10-06-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. The Officer was informed by the owner of the Sugar Hill Bakery that a person/s had taken without her authority or permission, and with intent to deprive her use, of an information sign from in front of her business. The Owner stated that she believed that the incident occurred during the night of October 05th 2016, between the hours of 20:00 and 07:00 on the 6th of October. The Owner went on to advise that on the afternoon of the 6th of October that the sign was returned, but that the supporting stand was damaged. No other issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 10-07-16- Officer while on patrol made multiple area checks of the city park for suspicious and/ or illegal activity/s. The Officer also made routine patrols of both residential and business properties, including P.O.A.Ps. The Officer while on patrol observed a suspicious vehicle and person in the area of Appling Land Fill. The area has recently been plagued with illegal dumping. The driver when he saw the patrol car made an abrupt U-turn and rapidly fled the area. Due to policy restrictions the Officer did give chase. The only information obtained was that the subject was a white male about 25 Y.O.A. driving an older model Ford pickup green in color with Georgia tags. No other incidents were observed by or reported to security personnel.
- 10-08-16- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. This did not exclude the P.O.A.P's listed. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 10-09-16- The Officer made routine patrols of both business and residential properties including the P.O.A.P.'s for suspicious and/or illegal activity/s. During the Officer's tour of duty no incidents were observed by or reported to Plaza Security LLC personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park ,Power Line Easements. Patrols also cover all other subdivisions.
