

The City of Sugar Hill  
Plaza Security Patrol Actions  
Nov.07th, 2016 – Nov.13th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 11-07-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious /and or illegal activity/is. While patrolling the Brogdon Business Park at approximately 00:29 hours, the Officer observed an inadequately dressed for the cold weather female walking from the rear of the closed businesses. The subject was wearing cut off shorts, sandals and a long sleeve shirt. She also had a backpack on her back. The Officer tried to maintain visual contact with the subject but lost visual contact. The Officer continued to monitor the area and regained visual contact of the subject in the parking lot of the Chevron convenience store. The Officer tried to approach the subject but when she saw him she left in a rapid manner. The subject stopped on the median between the Chevron and the Applebee's. The Officer inquired if she was ok or needed help. The woman responded that she was ok and was just waiting on a ride. The Officer left the location, but took up a surveillance point to monitor her actions. The woman would just roam around in the parking lot of the Chevron occasionally sitting on the curb. The Officer concerned that the subject was acting suspiciously contacted GCPD to have the subject checked out. The Officer maintained visual contact with the subject until two GCPD units arrived. The Plaza Officer listened to the conversation between the GCPD Officer and the subject. The subject was evasive and belligerent in her response to the questions asked by the Officer. Refusing to disclose her name or date of birth. When advised that she was subject to arrest the subject revealed her identity. The GCPD Officer checked the subject via N.C.I.C. and G.C.I.C. for wants and/or warrants. After a few minutes he returned and advised the subject to leave the area. She complied without incident. All Officers went back in service. While the Officer was locking up Gary Pirkle Park he observed two suspicious vehicles and upon closer investigation observed two suspicious persons. The Officer advised the subjects that the Park was closed and they needed to leave. The couple complied without incident and left. No other incidents were observed by or reported to security personnel.
- 11-08-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. No incidents or issues were observed by or reported to security personnel.
- 11-09-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. While on patrol the Officer received a phone call via the Post phone in reference to illegal parking. The Officer obtained the location from the complainant as being in the parking lot adjacent to the pool area of Abingdon Subdivision. Upon his arrival the Officer observed the vehicle; a Kia Sorrento the Officer then affixed a tow away warning sticker on a side glass of the vehicle. He then explained to the complainant that since the vehicle was on private property that he could not tow it, but that as a representative of the Subdivision that he could have it towed and was subject to the tow and any storage costs. The Officer then generated an incident report and went back in service. No other issues or incidents were observed by or reported to security personnel.
- 11-10-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 11-11-16- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. This did not exclude the P.O.A.P's listed. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 11-12-16- The Officer made routine patrols of both business and residential properties including the P.O.A.P.'s for suspicious and/or illegal activity/s. During the Officer's tour of duty she was requested to check the area of Sycamore Summit and Riverside Drive. The request was in reference to an excessive amount of noise and a large number of vehicles at the location. The time was 00:00 hours and the Officer spoke to the subjects, and was advised that they were wrapping the party up and people would be leaving soon. The Officer left without incident and checked back later and all was quite. The Officer then went back in service. No other incident/s were observed by or reported to Plaza Security LLC personnel.
- 11-13-16- The Officer made routine patrols of both residential and commercial properties checking for illegal or suspicious activities. During the Officer's tour of duty no incident or

complaints were made aware to Plaza Security LLC personnel.

- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park. Patrols also cover all other subdivisions.
