Plaza Security Patrol Actions
Nov.14th, 2016 – Nov.20th, 2016

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 11-14-16- Officer made routine patrols of both residential and business locations, and additional patrols of P.O.A.P.'s for suspicious /and or illegal activity/is. No incidents were observed by or reported to security personnel.
- 11-15-16-Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.'s. No incidents or issues were observed by or reported to security personnel.
- 11-16-16-Officer made routine patrols of both residential and business properties. The patrols included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were observed by or reported to security personnel.
- 11-17-16- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 11-18-16- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. This did not exclude the P.O.A.P's listed. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 11-19-16- The Officer made routine patrols of both business and residential properties including the P.O.A.P.'s for suspicious and/or illegal activity/s. No incident/s were observed by or reported to Plaza Security LLC personnel.
- 11-20-16- The Officer made routine patrols of both residential and commercial properties checking for illegal or suspicious activities. During the Officer's tour of duty no incident or complaints were made aware to Plaza Security LLC personnel.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
