## The City of Sugar Hill Plaza Security Patrol Actions Jul.27, 2018 – Aug. 02, 2018

- The following actions are specific significant actions taken during normal patrols throughout the
  City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded
  immediately to the Gwinnett County Police Department. Security officers request any illegal
  activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security
  acts as additional eyes and ears for the City and provides assistance when needed; however,
  they are not a police agency.
- 07-27-18-Officer made routine patrols of both residential and business properties. This also
  included, but was not limited to the P.O.A.P.s. No incidents or issues were observed by or
  reported to security personnel.
- 07-28-18- The Plaza Patrol Officer made several patrols of both residential and business properties to include P.O.A.P.'s in search of nefarious or illegal activities. Finding none and having none reported to the Officer he concluded his shift and departed.
- 07-29-18-Officer made routine patrols of both residential and business properties. The patrols
  included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were
  observed by or reported to security personnel.
- 07-30-18- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 07-31-18- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. At 2350 hrs. The Officer observed a tow truck drive behind his patrol car as he was locking the park up and head towards the rear of the parking area on the Austin Garner Rd. side of the park. The Officer secured the incoming gate and waited at the exiting gate for the tow truck. After a few minutes the tow truck approached the Officer's position with the Audi A-4 on the back. The Officer stopped the tow truck and requested his identification and proves that he was legally removing the vehicle. After obtaining the requested item the driver was allowed to exit. No other issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 08-01-18- The Officer made routine patrols of the commercial and residential properties. During
  these patrols were included the various P.O.A.P's. During these patrols no incidents or nefarious
  activities were reported to or observed by the Officer.
- 08-02-18- The Officer made routine patrols of both business and residential properties to check for illegal activities. While on patrol the Officer received a call from Megan, with Sugar Hill City Hall in reference to a suspicious female. From the description given it was a subject of who had been advised not to return to the Sugar Hill City Hall on 6/08/2018 by Sqt. Parrish. Upon arrival the Officer made a check of the area with negative contact. The Officer posted up on the western side of City hall and after a few minutes saw the subject walking up the side walk from the splash pad area. The Officer challenged the subject and inquired as to why she had returned to the City of Sugar Hill after being advised not to return or GCPD would be brought into the matter. The subject, known as Amanda Spence, this information was obtained from her Georgia State I.D. which she was carrying. She advised that she just needed a ride. The Officer advised her that he was contacting GCPD. The subject then began walking as the Officer was relaying her description to the GCPD Dispatcher. The subject was in a hurry and left her I.D. with the Officer. The dispatcher advised that she would have unit's en-route. The Officer advised that he would maintain a visual contact until they arrived. Upon their arrival The Officer gave them her I.D. and GCPD Officer McGraw Badge number 1925 issued a GCPD Criminal Trespass Warning to Ms. Spence advising her should she return, that all anyone in City Hall had to do was give the GCPD case # 18-071497 to Dispatch and a Unit would be dispatched and she would be arrested. Ms. Spence advised that she understood and was given a lift out of the city. These checks included but were not limited to P.O.A.P.'s. There were no other incidents observed by or reported to Plaza Security, L.L.C. personnel.
- NOTE: All shifts have maintained sporadic and numerous patrols and surveillance of the 1498
   Hillcrest Drive (aka the City Barn) location for unauthorized and or nefarious activities as a
   possible deterrent to future theft and /or damage to Sugar Hill properties.

Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Glens at Level Creek, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park. The House on Level Creek and the demolition site on First Ave. Patrols also cover all other subdivisions. Added to the current list is the Buice School for a period of 90 days due to equipment storage for the Actors Guild. The location known as the Orr's Ferry House located at 6180 Cumming Hwy. This will receive two visits per shift until further notice...
