## The City of Sugar Hill Plaza Security Patrol Actions Aug.03, 2018 – Aug. 14, 2018

- The following actions are specific significant actions taken during normal patrols throughout the
  City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded
  immediately to the Gwinnett County Police Department. Security officers request any illegal
  activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security
  acts as additional eyes and ears for the City and provides assistance when needed; however,
  they are not a police agency.
- 08-03-18-Officer made routine patrols of both residential and business properties. This also
  included, but was not limited to the P.O.A.P.s. No incidents or issues were observed by or
  reported to security personnel.
- 08-04-18- The Plaza Patrol Officer made several patrols of both residential and business properties to include P.O.A.P.'s in search of nefarious or illegal activities. Finding none and having none reported to the Officer he concluded his shift and departed.
- 08-05-18-Officer made routine patrols of both residential and business properties. The patrols
  included but were not limited to P.O.A.P.s for suspicious activity. No issues or incidents were
  observed by or reported to security personnel.
- 08-06-18- Officer made routine patrols of all P.O.A.P.'s, not neglecting residential and business properties. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 08-07-18- The Officer made routine patrols of both business and residential properties looking for suspicious and/or illegal activity/s. At 2350 hrs. No issues or incidents were observed by or reported to Plaza Security LLC, personnel.
- 08-08-18- The Officer made routine patrols of the commercial and residential properties. During these patrols were included the various P.O.A.P's. At 0000 hours while patrolling behind the Value Village the Officer observed two subjects in the dumpster. He ordered them out, of which they did without incident. They advised that due to a cardboard sign posted on the exterior of the dumpster that they believed it was now allowed to gather items from the dumpster. The Officer requested written documentation from management authorizing them to go through the contents of the dumpster. When they were unable to produce said documents the Officer told them to put all the items back into the dumpster. They complied and did so without incident. After doing this they left without incident. During these patrols no other incidents or nefarious activities were reported to or observed by the Officer.
- 08-09-18- The Officer made routine patrols of both business and residential properties to check
  for illegal activities. While on patrol the Officer at 1600 responded to Princeton Creek in
  reference to a call he had received from C.E.O. McDaniel in reference to an abandoned
  burgundy Chrysler Town and Country van in on April Dr. Upon arrival the Officer attempted to
  locate the vehicle's owner. After several attempts without success he contacted GCPD
  Dispatch and requested a Patrol unit to meet with him. Upon the Offices' arrival the GCPD
  Officer advised that he would only tag the vehicle. There were no other incidents observed
  by or reported to Plaza Security, L.L.C. personnel.
- 08-10-18- The Officer made patrols of both residential and commercial properties to try and deter illegal activities. This included but was not limited to P.O.A.P.'s. As the Officer was patrolling the overflow area of Pirkle Park on the Austin Garner Rd. side at 1500 hrs. he observed a dark in color BMW parked by one of the tractor and trailers stored there. As he approached the vehicle he noticed two subjects in the back seat of the car in various stages of undress. He tapped on the window, which resulted in a mad dash for the subjects to get dressed. The subjects lowered the windows and the Officer inquired what they were doing of which was apparent to the Officer. The Officer then requested the subjects Identifications which they both presented to the Officer. After confirming both were adults the Officer advised them to find a more suitable location for their activities. The subjects agreed and left the area without incident. Later in the evening the Officer was approached by a British tourist looking for the soccer fields. The Officer was only familiar with the fields located at Gary Pirkle Park. He advised the Gentleman if he wanted that he could follow the patrol car and that the Officer would be more than happy to lead him to his destination. The Gentleman was surprised of the Officer's curiosity and was led to the soccer fields. No other incidents were observed to Plaza Security LLC personnel.
- 08-11-18-The Plaza Officer made numerous patrols of both Commercial and Residential properties, this included but not limited to the numerous P.O.A.P.'s. During these patrols the Officer made sure to show a presence in an attempt to deter illegal activities. The Officer did

- not observe nor had any incidents reported to him or the Company,
- 08-12-18- The Plaza Officer made numerous patrols of Residential and Commercial properties; this included but was not limited to P.O.A.P.'s. The Officer's basic duty is to try and observe and deter any illegal activities and be a supplemental device for the over worked and thinly stretched GCPD. During his tour of duty the Plaza Officer reports any suspicious activity to the GCPD for further investigation should they deem it necessary. No incidents were observed by or reported to the Officer or Company.
- 08-13-18- The Plaza Officer made numerous patrols of Commercial and Residential properties, this including but not limited to the P.O.A.P.'s. During his tour of duty no incidents were reported to or observed by the Officer.
- 08-14-18- The Plaza Officer during his patrols of the Residential and Commercial properties, this
  including but not limited to the P.O.A.P.'s. No unusual or illegal activities were observed or
  reported to the Officer or Company.
- NOTE: All shifts have maintained sporadic and numerous patrols and surveillance of the 1498
   Hillcrest Drive (aka the City Barn) location for unauthorized and or nefarious activities as a
   possible deterrent to future theft and /or damage to Sugar Hill properties.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pinecrest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Glens at Level Creek, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pinecrest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The City of Sugar Hill Splash Park. The House on Level Creek and the demolition site on First Ave. Patrols also cover all other subdivisions. Added to the current list is the Buice School for a period of 90 days due to equipment storage for the Actors Guild. The location known as the Orr's Ferry House located at 6180 Cumming Hwy. This will receive two visits per shift until further notice...
