

The City of Sugar Hill
Plaza Security Patrol Actions
Feb.23rd, 2020 –Feb.29th, 2020

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 02-23-20- The Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.s this included Riverside Walk, also Kendrix Ridge is still being patrolled more often. Continued emphasis was given to the E-center due to previous incidents. During the day the Officer encountered a total of 18 skateboarders in the commons, in the corner of the E-center Complex and in the lower parking deck of the City Hall. All were juveniles and exited without incident when advised that they were not allowed on City Property. No other incidents or issues were observed by or reported to security personnel.
- 02-24-20-The Officer made several patrols of both residential and business properties to include the listed P.O.A.P.'s in search of nefarious or illegal activities. Also patrols were made as well as escorts of Recreation Staff at the E-center. No issues were observed by or reported to the Officer.
- 02-25-20-The Officer made routine patrols of both residential and businesses properties, this including the P.O.A.P.s The E-center was found secure and the Recreation Staff was escorted at the end of their to their vehicles. No incidents or issues were reported to /or observed by the Officer.
- 02-26-20-The Officer made patrols of the residential and commercial properties including the P.O.A.P.'s. Due to recent abnormalities at the E-center the Officers have been focusing their attention on it until it closes and then take care of the other tasks within the remaining time frame allotted. No incidents or issues were observed by or reported to the Officer or Shift Supervisor during his tour of duty.
- 02-27-20- The Officer made sporadic checks of the business and residential properties, including the P.O.A.P.s Spending most of the time in and around the E-center. No issues or incidents were observed by or reported to the Officer.
- 02-28-20- The Officer made routine patrols of the residential and business properties of which included the P.O.A.P.s., with a high emphasis on the E-center complex. While in the Recreation Section of the E-center the Officer observed two juveniles playing ping-pong. As he watched it became apparent that they were trying to damage the equipment, the Officer advised them to stop trying to damage the equipment. The subjects put the paddles and ball up at that point. When they started to leave one got on his skateboard and started to ride it inside the Recreational Area. The Officer loudly advised the subject to get off of his skateboard and advised that he was not permitted to ride his skateboard on City property. As they were leaving the subjects took a left and headed down the hall towards the Waterfall room. The Officer went the opposite direction in an attempt to head them off. As he rounded the corner he observed the subjects exiting the restroom and he then re-routed them to the exit. The Officer followed the subjects outside and observed them running towards the common area between the E-center and the Eagle Theater, where he lost sight of them. No other issues were reported the Officer or the Shift Supervisor.
- 02-29-20- The Officer made checks of both residential and business properties in an attempt to deter crime. Primary patrol was around and in the E-center. At 11:00 hrs. The Officer made contact with GCPD after observing a white Mazda Miata in the lower parking lot of the City Hall. The Officer had noticed that the vehicle was in the same location on Friday night at 00:00hrs and hadn't moved overnight. Upon closer investigation he noticed that the steering column had been cracked, being former Law Enforcement he knew this to be a good indicator that the vehicle was possibly stolen. He contacted GCPD and advised them the tag number and last 4 of the VIN (Vehicle Identification Number). After a few minutes he was advised that the vehicle was not reported stolen. He advised that he would contact City Hall to see what they wanted to do with it should it still be there on Monday 20.03.02. At 13:55 hrs. The Officer received a call from a resident in the Secret Cove Subdivision. The Resident advised that a subject had come to her house and tried to solicit home improvements. After he left she called the Officer to advise that he was in the neighborhood. The Officer conducted an area sweep of the Subdivision and located a subject fitting the general description. The Officer set up in a position so as to have clear visual of the subject of who was in the middle of a sales pitch. After the subject finished and started to

leave the Officer motioned for the subject to walk over to his location. Upon the subject's arrival the Officer inquired as to what he was doing? The subject advised he was scheduling appointments for an estimator to come out and give estimates on home improvements. When asked for a Solicitor's Permit, the subject advised that he only had one for Cherokee County. The subject was advised that he needed a minimum of at least a Gwinnett County permit, and that he needed to leave the subdivision, because a Gwinnett County Solicitor's Permit would only technically be valid for Un-incorporated Gwinnett County and since he was inside a City limits would not be valid. The subject apologized and called his ride to pick him up. Upon his ride's arrival the subject left without incident. During the Officer's tour of the E-center he encountered a group of 4 juveniles who had continued to sneak into the E-center after being told by the Recreation staff due to them being under age and not members and unescorted by their parents that they could not be there. The subjects departed without further incident. At approximately 17:30 hrs. The Officer encountered 4 subjects in the E-center with skateboards. The Officer advised the subjects that they were not allowed to ride their skateboards in the E-center or on the City property. The subjects left without incident. During the Officer's tour of duty no other incidents or issues were noted or reported to the Officer or the on duty Supervisor.

- NOTE: All shifts have maintained sporadic and numerous patrols and surveillance of the 1498 Hillcrest Drive (aka the City Barn) location for unauthorized and or nefarious activities as a possible deterrent to future theft and /or damage to Sugar Hill properties.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pine crest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Glens at Level Creek, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pine crest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The House on Level Creek and the demolition site on First Ave. Patrols also cover all other subdivision. The location known as the Orr's Ferry House located at 6180 Cumming Hwy. Daniel Creek was added on September, 24, 2018. Added were the Eagle Theater and E-Center. This P.O.A.P. will focus on unauthorized persons in the parking decks, in particular subjects loitering, skateboarding, or sitting in their vehicles for long periods of time.
