The City of Sugar Hill Plaza Security Patrol Actions Mar.01st. 2020 –Mar.06th. 2020

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 03-01-20- The Officer made routine patrols of both residential and business properties. This also
 included, but was not limited to the P.O.A.P.s this included Riverside Walk, also Kendrix Ridge is
 still being patrolled more often. Continued emphasis was given to the E-center due to previous
 incidents. During the day the Officer encountered a total of 18 skateboarders in the commons, in
 the corner of the E-center Complex and in the lower parking deck of the City Hall. All were
 juveniles and exited without incident when advised that they were not allowed on City Property.
 No other incidents or issues were observed by or reported to security personnel.
- 03-02-20-The Officer made several patrols of both residential and business properties to include the listed P.O.A.P.'s in search of nefarious or illegal activities. Also patrols were made as well as escorts of Recreation Staff at the E-center. No issues were observed by or reported to the Officer.
- 03-03-20-The Officer made routine patrols of both residential and businesses properties, this
 including the P.O.A.P.s The E-center was found secure and the Recreation Staff was escorted at
 the end of their to their vehicles. No incidents or issues were reported to /or observed by the
 Officer.
- 03-04-20-The Officer made patrols of the residential and commercial properties including the P.O.A.P.'s. Due to recent abnormalities at the E-center the Officers have been focusing their attention on it until it closes and then take care of the other tasks within the remaining time frame allotted. While conducting his pre-tour vehicle inspection, the Officer observed a GCPD Patrol Unit enter the lower parking area and drive through. The Officer observed the GCPD Unit enter into the E-center and Eagle Theater parking area and in a few minutes exit it as if he were looking for something. After completing his inspection the Officer drove through the E-center lower parking area and onto what he thought was a driveway onto West Broad St. As he exited the parking area he observed a dark colored passenger car with its hazard lights on. The Officer still believing the area was a driveway and seeing the vehicle unattended and having its hazard lights on went about his patrolling. As the Officer was preparing to leave for the night he observes the vehicle was still on site and still was unattended and had the hazard lights on. No incidents or issues were observed by or reported to the Officer or Shift Supervisor during his tour of duty.
- 03-05-20- The Officer made sporadic checks of the business and residential properties, including the P.O.A.P.s Spending most of the time in and around the E-center. The Officer upon arriving at the Sugar Hill City Hall lower parking lot made contact with Tim Schick, with The City of Sugar Hill, due to receiving a call from him at 10:19 in reference to the abandoned vehicle. He was advised by Mr. Schick that the vehicle had been left on a street. The Officer advised that he was unaware that the vehicle was on a street believing it to be a driveway due to the lack of signage advising that it was in fact Level Creek Rd. Extension. The Officer advised that if he had been aware of the location being a street as oppose to a driveway that the vehicle would have been towed on the previous date. No other issues or incidents were observed by or reported to the Officer.
- 03-06-20- The Officer made routine patrols of the residential and business properties of which included the P.O.A.P.s., with a high emphasis on the E-center complex. No issues were reported the Officer or the Shift Supervisor.
- 03-06-20- The Officer made checks of both residential and business properties in an attempt to deter crime. Primary patrol was around and in the E-center. The Officer while conducting a check of the E-center, observed 6 subjects in the Bowl on the stage. The Officer exited the E-center and walked over and ordered the subjects to leave the area. He then had to advise them that they could not loiter in the lower parking area of City Hall. One juvenile male in particular began becoming belligerent and was advised if he did not leave then GCPD would escort his off. The subjects then left without further incident. Later in the day the Officer observed another group trying to gain access to Bowl and was advised to leave which they did without incident. At approximately 16:00 hrs. the Officer observed a subject riding his skateboard down Temple Dr. on the sidewalk in the direction of City Hall. As the Officer reached the City Hall Parking lot he lost visual of the subject. After searching the area he observed the subject skateboarding around the

pond. The Officer advised the subject that he was not allowed to ride his skateboard in the Ecenter or on the City property. The subject left without incident. During the Officer's tour of duty no other incidents or issues were notated or reported to the Officer or the on duty Supervisor.

- NOTE: All shifts have maintained sporadic and numerous patrols and surveillance of the 1498 Hillcrest Drive (aka the City Barn) location for unauthorized and or nefarious activities as a possible deterrent to future theft and /or damage to Sugar Hill properties.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pine crest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Glens at Level Creek, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pine crest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The House on Level Creek and the demolition site on First Ave. Patrols also cover all other subdivision. The location known as the Orr's Ferry House located at 6180 Cumming Hwy. Daniel Creek was added on September, 24, 2018. Added were the Eagle Theater and E-Center. This P.O.A.P. will focus on unauthorized persons in the parking decks, in particular subjects loitering, skateboarding, or sitting in their vehicles for long periods of time.
