

The City of Sugar Hill
Plaza Security Patrol Actions
Mar.15th. 2020 –Mar.21st. 2020

- The following actions are specific significant actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Security officers request any illegal activity be reported to them and also be reported to Gwinnett County Police Dept. Plaza Security acts as additional eyes and ears for the City and provides assistance when needed; however, they are not a police agency.
- 03-15-20- The Officer made routine patrols of both residential and business properties. This also included, but was not limited to the P.O.A.P.s this included Riverside Walk, also Kendrix Ridge is still being patrolled more often. Continued emphasis was given to the E-center due to recent incidents. The Officer while conducting over watch of the Sugar Hill Government Complex from the gravel parking lot observed two subjects on the 3rd floor landing of the exterior stairwell of the E-center. The Officer brought up the image on the Ring app on the phone and observed two white males. The Officer then raced over to the Commons Area where he observed the subjects standing by the Golden Rules sign. The Officer approached and asked the men if they were from a real estate company? They advised no. The Officer then asked why they were on the 3rd floor landing of the E-center building. The Officer also asked if they had seen the Do Not Enter sign posted across the walkway. They apologized for being up there and advised they just wanted to take a picture. The Officer advised them that they were not allowed up there and any further violations would be referred to GCPD for possible prosecution. The subjects again apologized and left without incident. No other incidents or issues were observed by or reported to security personnel.
- 03-16-20-The Officer made several patrols of both residential and business properties to include the listed P.O.A.P.'s in search of nefarious or illegal activities. Also patrols were made as well as escorts of Recreation Staff at the E-center. No issues were observed by or reported to the Officer.
- 03-17-20-The Officer made routine patrols of both residential and businesses properties, this including the P.O.A.P.s The E-center was found secure and the Recreation Staff was escorted at the end of their to their vehicles. No incidents or issues were reported to /or observed by the Officer.
- 03-18-20-The Officer made patrols of the residential and commercial properties including the P.O.A.P.'s. Due to recent abnormalities at the E-center the Officers have been focusing their attention on it until it closes and then take care of the other tasks within the remaining time frame allotted. While conducting a patrol outside of the E-center the Officer observed 3 skateboarders riding down the sidewalk in front of the E-center. The Officer shouted at the subjects not to ride their skateboards on the sidewalk. The subjects continued on towards the RaceTrac. The Officer went into the E-center where he escorted the Recreation Department Employee to her vehicle, without incident. Later at about 18:00 hours while talking with Captain Tate ,Plaza Security ,L.L.C., the group returned and did not get on their skateboards until just past the Officer. They continued riding their skateboards west until they reached Temple Drive. At 22:20 hours while patrolling in the area of the Eagle Theater and the E-center complex the Officer observed a subject sitting in front of Rushing Trading Co., with his head on the table. The Officer made a U turn and approached the subject. The Officer advised the subject that he could not be there due to the late hour and that all the businesses were closed. The subject got up and walked into the Commons Area and sat at on a bench. The Officer advised him that he could not be there either. The subject stated that a posted sign advised that the area was open 24 hours a day. The Officer again told him to leave and he refused. The Officer then advised he was calling GCPD, to which the subject responded" go ahead!" The Officer contacted GCPD dispatch and after a few minutes a GCPD Officer arrived. The Officer upon arrival was briefed on what had transpired prior to his presence being requested. The Officer spoke to the subject and advised him since the Officer was a representative of the City that the subject should have left. But that since he did not leave he was being issued a Criminal Trespass Warning. The Officer advised the subject that violating the Criminal Trespass Warning could result in arrest. The subject advised he understood what was going on since he was Criminal Trespassed from Buford. The subject left with his copy of the Criminal Trespass Warning without further incident. No other incidents or issues were observed by or reported to the Officer or Shift Supervisor during his tour of duty.
- 03-19-20- The Officer made sporadic checks of the business and residential properties, including the P.O.A.P.s Spending most of the time in and around the E-center. The Officer observed a pack of 3 subjects in the parking area of the E-center on skateboards. He dispersed them and a

smaller group about 10 minutes later, all juveniles. No other issues or incidents were observed by or reported to the Officer.

- 03-20-20- The Officer made routine patrols of the residential and business properties of which included the P.O.A.P.s., with a high emphasis on the E-center complex. While patrolling the Subdivisions on Whitehead Road the Officer encountered solicitors in Oaks at Lanier, Brighton Park and Saddle Tree. None of them even had Gwinnett County Solicitor's permits and were violating the signs at the front of the subdivisions, prohibiting solicitation. All left without any incident. At 18:00 hours the Officer received a call from EMC Security in reference to an alarm at the Sugar Golf Club. The Officer responded and upon arrival noticed a lot of people still utilizing the facility. After conducting a check of the exterior of the sides and rear of the building the Officer went to the front and was stopped by a patron, who advised if he was there for the alarm that the patron had set it off when he went to the restroom. The patron advised that when he pulled on the door that it was not secured. The Officer went to the doors and the left door was not secure and opened. The Officer realizing that the alarm was again tripped contacted the alarm company and advised that he had set the second alarm off and gave them the pas code. No other issues were reported the Officer or the Shift Supervisor.
- 03-21-20- The Officer made checks of both residential and business properties in an attempt to deter crime. Primary patrol was around and in the E-center. During the Officer's tour of duty no incidents or issues were notated or reported to the Officer or the on duty Supervisor.
- NOTE: All shifts have maintained sporadic and numerous patrols and surveillance of the 1498 Hillcrest Drive (aka the City Barn) location for unauthorized and or nefarious activities as a possible deterrent to future theft and /or damage to Sugar Hill properties.
- POAP: Primrose Creek, Saddle Tree, Whitehead Rd., Westbrook Commons, Pirkle Park
- Multiple patrols performed throughout the following locations due to previous incidents: Pine crest Station, Kendrix Ridge, Sugar Crossing, Hillcrest Woods, Duncan Town, Sycamore Summit, Frontier Forest, Park View, Sugar Woods, Pine Pavilion Estates, Saddle Tree, Lakefield Forest, Glens at Level Creek, Fairview Park, Sugar Hill Plantation, Richland Creek, Creekside at Pine crest, Cobblestone Park, Spring Hill Plantation, Park at Barrington Estates, Avonley Creek, Cypress Springs, Bent Creek, Hickory Hills and Benfield Road, The House on Level Creek and the demolition site on First Ave. Patrols also cover all other subdivision. The location known as the Orr's Ferry House located at 6180 Cumming Hwy. Daniel Creek was added on September, 24, 2018. Added were the Eagle Theater and E-Center. This P.O.A.P. will focus on unauthorized persons in the parking decks, in particular subjects loitering, skateboarding, or sitting in their vehicles for long periods of time.
