- The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded to the Gwinnett County Police Department. Plaza Security is not a police agency.
- 05-31-20-The Officer conducted patrols and had nothing to report.
- 06-01-20-
- INCIDENT: The Officer was present along with a second Plaza Security in response to a gathering at City Hall. There was a group of approximately 100 individuals gathered at the City Hall in a peaceful protest over political matters. The rally lasted approximately 2 hours with no incidents reported.
- 06-02-20-The Officer made routine patrols and had nothing to report.
- 06-03-20-
- INCIDENT: The Officer while on foot patrol in the parking area of the E-center was made aware of a situation by a small group of juveniles. The Juveniles advised the Officer of a SUV that had two dogs in it and they were concerned about the wellbeing of the animals. The Officer made attempts to locate the owner with no success. When the Officer was about to contact GCPD a worker from Central City Tavern advised the location of the animal owner. While en-route to talk to the owners they walked out of the elevator. As it turned out the owner had just walked the dogs in the time that the Officer was looking for the owner. The animals were fine and no report was made.
- INCIDENT: While patrolling in the area of the new American Legion the Officer found the gate to the construction site open. Upon first investigation the Officer found no one in the site and there was a lock cut on the gate. The Officer then contacted GCPD to determine if the incident had already been reported. The Dispatcher advised it had not been reported. The Officer then requested a Patrol Unit be dispatched to the incident location. While waiting the Officer contacted Mr. Besseche, Assistant City Manager for Sugar Hill, who had initially advised of the job site location several months ago. The Officer relayed the information he had and Mr. Besseche advised after GCPD Officer/s arrived to update him. Upon arrival the Officers along with the Plaza Security Officer entered into the construction site. After a while they all exited. The Plaza Officer advised them that a large white work truck was missing. The Plaza Officer advised he knew that it was not there since he checks this location at least 5 times a week. The GCPD Officers asked if the Plaza Officer had contact information for the job site Supervisor, at first the Plaza Officer said he did not have that information. The Plaza Officer then contacted Mr. Besseche who texted him the number for Gary Evans, the construction site Supervisor. The Plaza Officer contacted Mr. Evans who advised that his crew had cut the lock because the tower workers had locked his crew out of the job site. Mr. Evans also advised that the large work truck had probably had been moved by its owner since he had told him to stop storing it on the job site. He did express appreciation for the Officer finding his job site unsecured and advised if he did find anything missing that he would contact GCPD the following day.
- 06-04-20-
- INCIDENT: At 19:00 hours the Officer received a call from Lt. Najibullah in reference to an illegally parked car on Bent Creek Court. The Officer conducted an area check of the street and had contact with one vehicle fitting the description of the vehicle. The vehicle the Officer found was legally parked in his driveway.
- 06-05-20- The Officer made patrols with nothing to report.
- 06-06-20-
- INCIDENT: The Officer received a call from a member of the Riverside Walk HOA in reference to subjects in the pool and refusing to leave. The Officer advised as long as a member of the HOA was present that he would be able to help. The HOA member agreed to meet the Officer at the pool. Upon arrival at the pool Officer noticed that no one was there. The Officer contacted the Complainant who advised when the subjects were made aware that he was en-route that they left without further incident.
- INCIDENT: The Officer met with Lindsey an employee of Sugar Hill and was advised that he

would be needed until the 3 GCPD Officers arrived for the Town Meeting being held at the Bowl. The Officer waited until the 3 GCPD Officers arrived and then took up an over watch position where he had an unobstructed view of the location and activities. The Officer monitored the activities until the meeting was over.
