- The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded to the Gwinnett County Police Department. Plaza Security is not a police agency.
- 06-07-20-The Officer conducted patrols and had the following to report:
- INCIDENT TYPE: ILLEGAL BURNING, The Officer while patrolling near the intersection of
 Hillcrest Drive and Nelson Brogdon Blvd. observed a large amount of smoke coming from a
 subdivision off of Hillcrest Drive. Upon checking the area the Officer located the source of the
 smoke. The address was 1140 Hillcrest Glenn Circle. The Officer made contact with the
 Homeowner and advised that there is a burning ban. The Homeowner advised the Officer that he
 was unaware of the ban and extinguished the blaze without incident.

INCIDENT TYPE: ILLEGAL PARKING, while patrolling the Princeton Oaks Subdivision the Officer observed a tractor parked in a driveway on Oakley Court. The Officer obtained documentation for the Code Enforcement Department and forwarded it to them for possible prosecution

- 06-08-20-The Officer made routine patrols and had nothing to report.
- 06-09-20- The Officer made routine patrols and had this to report:
- EVENT: The Officer while conducting a check of the Orr Ferry House was temporarily cut off
 due to a sudden down pour. The Officer had just completed his check of the house when while
 attempting to leave he found that the creek had now become a river blocking his exit over the
 bridge. After the water subsided the Officer was able to safely leave. The structural integrity of the
 bridge appeared to be adequate to permit his departure from the area.
- 06-10-20- The Officer conducted patrols and had nothing to report.
- 06-11-20- The Officer made patrols with the following to report:
- INCIDENT TYPE: SUSPICOUS ACTIVITY, The officer while preforming a routine security check of the gate preventing access to the new American Legion site observed a burgundy motorcycle parked outside the gate. As the Officer watched he saw a male subject along the outside of the fence on an adjacent service road. Continuing to observe the proceedings he observed that the subject had circumvented the gate and was now inside the fenced area. The Officer exited his patrol vehicle and made contact with the subject. He inquired as to what he was doing inside the fence. The Subject identified himself as a member of the Buford American Legion and advised that he had permission to be there. The Officer inquired as to why he had gone in through the hole in the fence instead of entering through the gate. The subject could not come up with a good reason. After questioning the subject and seeing his credentials the Officer contacted the site Supervisor. The Officer only got the Supervisor's answering machine. The Supervisor contacted the Officer, but the Subject was gone. The Supervisor advised he knew the Subject, but by an alias.
- 06-12-20-The Officer conducted routine patrols and had this to report:
- INCIDENT TYPE: SUSOICOUS ACTIVITY, The Officer while patrolling the Barrington Estates Pierless Subdivision observed a vehicle at the pool. The Officer decided to investigate since it was after midnight. Upon arrival the Officer observed a red Toyota Prius. As the Officer parked his vehicle he noticed the vehicle start backing up. He ordered the Driver to halt, but the Driver continued to back until he struck the curb and backed over it. The Officer then proceeded to the Driver's side of the vehicle. He observed a young male behind the wheel and no one else in the vehicle. The Officer ordered the subject to turn off the vehicle's engine. After giving this command several times the subject complied. The Officer asked for the Driver's License. The Driver advised he did not have one because he was only 14 Y.O.A... The Officer then advised the Subject to contact his Parents. The Subject and his Mother walked up to the pool and took possession of the vehicle and her Son.
- INCIDENT TYPE: LARGE GATHERING, At 22:03 hours the Officer received a call from Mr. Besseche City of Sugar Hill, Assistant City Manager in reference to a large crowd on the Plaza near the Splash Pad. Mr. Besseche requested the Officer see what was going on and report his findings to him. The Officer drove to the area and made contact with an Adult male who

advised that they had concluded a Bible study and was having a bite to eat. The Officer thanked him and called Mr. Besseche and advised him the findings. The Officer was instructed to advise them that unless it was a scheduled City function that the area was closed at Dusk. The Officer relayed the message and the subjects left without incident.

- 06-13-20- The Officer made patrols of the reported the following:
- INCIDENT TYPE: TRESPASSING, The Officer while on patrol on Cumming Hwy. observed a gray van parked outside of the gate at the Central City Park. The Officer investigated and encountered 2 families. He advised them that they were trespassing and would need to leave. The Group apologized and left without incident.
