The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Plaza Security is not a police agency.

06-14-20 Sun -The Officer conducted patrols and had nothing to report.  
06-15-20 Mon -The Officer conducted patrols and had nothing to report  
06-16-20 Tues -The Officer made routine patrols and had nothing to report.

06-17-20 Wed -The Officer made patrols and had the following to report:  
**INCIDENT TYPE: SOLICITORS** The Officer while patrolling Bent Creek Subdivision observed two subjects which appeared to be soliciting. Upon investigation he discovered that the two were giving “estimates on roofing “. The Officer requested to see their Gwinnett County Solicitor’s Permits. Neither of the subjects could provide any documentation authorizing them to Solicit. The Officer requested that they leave, which they did without incident.

**ASSISTANCE:** The Officer assisted the floor refinisher in the E-center with lighting issue on the 1<sup>st</sup> and 3<sup>rd</sup> floors .doors on the first floor.

06-18-20 Thru - The Officer made patrols and had the following to report.  
**INCIDENT TYPE: ILLEGAL PARKING** The Officer while patrolling the Sugar Hill Station Shopping Center observed a Driver with a tractor and trailer which has been Illegally Parking over in conflict with City Ordinance prohibiting such activities. The Driver of the Crane Trucking vehicle advised that he was unaware of his actions being against the Law. He stated that he had been doing this for 4 years, but since it is prohibited then he would refrain from parking it there in the future.

**INCIDENT: LARGE GROUP OF SUBJECTS** At 2135 hours after concluding the E-center escort the Officer observed a large group of subjects on the Plaza. The Officer went over to the Plaza and advised all the subjects that unless there was a City Sanctioned event that that area was closed at sunset. The subjects packed up and left without incident.

**INCIDENT: UNSECURED GATE** The Officer was patrolling the area just outside of the New American Legion when he observed something odd about the chain. Upon closer examination the Officer discovered that the gate was dummy locked. The padlock was locked but did not connect with the opposite side of the chain. The Officer also found the key box was open and the key to the padlock was still inside. The Officer contacted the Site Supervisor and apprised him of the situation. The Subject asked the Officer if he could secure the yard. The Officer said he would and after hanging up with the Supervisor he secured the yard.

06-19-20 Fri. -The Officer made patrols and had the following to report:  
**ASSISTANCE: EXTRA ATTENTION** The Officer received a call from Andy McQuagge, Director of the Recreation Department requesting extra patrols in the E-center parking deck. Mr. McQuagge advised that there was a pallet of bricks in the parking deck and requested that we keep an eye on them throughout the weekend. The Officer advised him that it would be looked after.

**INCIDENT: ILLEGAL PARKING** The Officer while patrolling the Sugar Hill Shopping Center Parking lot observed a Tractor and Trailer parked across several parking spaces. The Officer approached the vehicle and knocked on the door of the cab. A gentleman came from the sleeper area and asked what was going on. The Officer inquired as to whether or not the vehicle was going to be there for the night, the Driver advised no that he was leaving in 30 minutes. The Officer thanked him and left.
