

The City of Sugar Hill
Plaza Security Patrol Actions

The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Plaza Security is not a police agency.

07-26-20 Sun -The Officer conducted patrols and had the following to report:

INCIDENT: DUCKS FLED THE POND: The Officer while patrolling noticed that the Ducks had fled the Pond next to the Bowl. When he observed the Ducks they were waddling towards the Former Sugar Hill Community Center now known as the Sugar Hill Distillery. The Officer rounded the Ducks up and herded them back safely back to the pond without incident.

07-27-20 Mon -The Officer conducted patrols and had nothing to report.

07-28-20 Tue- The Officer conducted patrols and had nothing to report.

07-29-20 Weds-The Officer made patrols and had the following to report:

INCIDENT: GRAFFITTI: The Officer while on patrol in the Sugar Hill Station Shopping Center observed graffiti behind a business. The Officer observed the graffiti located on a wall located at 4450 Nelson Brogdon Blvd. Suites C7 and D3 respectively. Photos were obtained and an incident report was generated.

07-30-20 Thru - The Officer made patrols and had nothing to report.

INCIDENTS: SUSPICIOUS PERSONS: At 22:20 hours while on patrol in Gary Pirlke Park the Officer observed a vehicle in the Park after the Park was closed. When the headlights illuminated the vehicle the Officer observed frantic movements inside of the vehicle. As the Officer exited his vehicle and cautiously approached he observed unclothed persons inside. The Officer made contact and inquired as to why the subjects, a male and a female were still in the Park considering that the Park was closed and that there is signage advising when the Park is open to the Public. The female advised that they were just hanging out. The Officer then asked the subjects their ages and was advised by both that they were 16 Y.O.A... The Officer then advised the subjects to contact their Parents and have them en-route.

07-31-20- Fri – The Officer made patrols and had following to report:

ACTIVITY: OVERWATCH: The Officer upon arrival at City Hall at 16:00 hours observed a large amount of pedestrian and vehicular traffic uncommon for a weekday. Upon numerous attempts to find out what was going on and if he needed to remain in the area as opposed to starting his patrol. The Officer finally found out from Andy McQuagge, Director of the Recreation department that it was a Back to School event. The Officer was later contacted by Mr. Schick in reference to juveniles attempting to gain access to the VIP suite. The Officer but had negative contact. The event concluded at approximately 20:00 hours without any further reports of issues.

INCIDENT: LARGE GROUP OF JUVENILES: The officer while on patrol by the Splash Pad at 22:30 hours, observed that a large group of subjects that had gathered on the top parking deck at City Hall. What concerned the Officer was that some of the groups were sitting on the wall of the parking enclosure hanging their legs over the wall. The Officer immediately drove to the location. Upon arrival he observed approximately 10-12 young people skateboarding and generally playing in the parking lot. Due to their apparent disregard for life and property the Officer advised them to leave City property. The subjects loaded up in four vehicles and left without further incident.

08-01-20 Sat. -The Officer made patrols and had following to report:

ACTIVITY: PROTEST: The Officer had been advised of a possible protest rally at City hall. Upon arrival at 10:00 hours the Officer observed several subjects in front of City Hall. The Officer observed GCPD presence in the area. The rally was concluded at 11:30 hours with no incidents to report.
