The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Plaza Security is not a police agency.

08-02-20 Sun -The Officer conducted patrols and had nothing to report.

08-03-20 Mon -The Officer conducted patrols and had nothing to report.

08-04-20 Tue- The Officer conducted patrols and had the following to report:

**INCIDENT: DUCKS MISSING:** The Officer while checking the area of the pond for the Ducks was concerned when he could not locate them. He immediately contacted the site Supervisor and advised him of the situation. The Supervisor advised him to canvas the area and see if they had wandered off again. The Officer did and later contacted the Supervisor and advised that the Ducks were nowhere to be found. Due to the late hour the Supervisor advised the Officer to generate an incident report and not to contact Mr. Schick. On the following day the Supervisor was advised that the Ducks had been picked up by the Veterinarian for a checkup and that Mr. Schick was not even aware of the activity.

08-05-20 Weds-The Officer made patrols and had the following to report:

**INCIDENT: GRAFFITTI**: The Officer while on patrol in Walgreen's parking lot observed graffiti on the Red Box machines. Continued notation will be made.

INCIDENT: PERSONS AT PIRKLE PARK: While on patrol the Officer received a call from Mark McKain at Pirkle Park.
