The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Plaza Security is not a police agency.

11-9-20 Mon – The Officer made patrols and had nothing to report.  
11-10-20 Tue - The Officer made patrols and had nothing to report.

11-11-20 Wed – The Officer made patrols and had this to report:  
**INCIDENT: EMERGENCY VEHICLE: POLICE** – At around 05:28pm the officer on duty for patrols around city hall and Ecenter reported police and EMT present at Broadstone Sugar Hill, the apartment complex off of Alton Tucker Rd across from city hall. The officer made contact with Gwinnett police officer Kurowski badge 1082 and request information on the situation. The officer declined stating he could not give Plaza Security's officer any information on what had taken place at the apartment complex. No further information on this issue was obtained.

**INCIDENT: SUSPICIOUS ACTIVITY** – At 10:35pm Officer on duty came upon the fountain at Laural Park off of Suwanee Dam Rd on the right side as one enters the area to be covered in white foam due to unknown persons putting tide in the fountain. No persons seen in area at time of discovery. No further information on this incident was obtained.
