The following is a summary of actions taken during normal patrols throughout the City. Plaza Security patrols the City on a daily basis and any criminal act is forwarded immediately to the Gwinnett County Police Department. Plaza Security is not a police agency.

08-30-20 Sun -The Officer conducted patrols and had this to report:

**INCIDENT: TRESPASSING** - The Officer while checking the Central City Park observed that 2 adult males and a juvenile male had ignored the No Trespassing signs and were fishing in the pond. The Officer politely advised them that they were trespassing on City property and the subjects left without incident.

08-31-20 Mon -The Officer conducted patrols and had nothing to report.

09-01-20 Tue- The Officer conducted patrols and had nothing to report.

09-02-20 Weds-The Officer made patrols and had nothing to report.

09-03-20 Thru - The Officer made patrols and had nothing to report.

09-04-20- Fri – The Officer made patrols and had this to report:

**INCIDENT: CRIMINAL TRESPASS**- The Officer was advised by the GCPD Officer to an incident which had occurred at the Sugar Hill Bakery/Cafe' located at the intersection of Alton Tucker Blvd. and West Broad Street. It was found that a person/s had dumped a container of black paint on both sides of the sandwich board sign obliterating the verbiage. The sign at the time was located in front of the business, which at the time was closed. No person/s was observed in the immediate area.

09-05-20 Sat. -The Officer made patrols and had this to report:

**INCIDENT: SOLICITOR IN WILD TIMBER**- The Officer while on routine patrol in the Wild Timber Subdivision encountered a subject wearing AT&T attire going from door to door. The Officer made contact and was advised from the subject that he only had a DeKalb County Solicitor's permit. The Officer advised him to exit the subdivision. Approximately 20 minutes later the officer was advised to return a call to a Resident in Wild Timber. Upon making phone contact with the Resident he was asked if Plaza Security made patrols in Wild Timber. The Officer advised that he had just been in the subdivision and had in fact ran off a solicitor. The Resident advised that she had been approached by the same subject twice earlier and had not known what to do! The Officer verified that she had the phone number to the car and advised her to contact the number if she ever had another concern. The Resident thanked the Officer for the City's response before she'd even called. The Officer requested that the Resident make sure that the Plaza Security/ Sugar Hill Patrol was posted on the Wild Timber website, and she stated that she would.

**SPECIAL REQUESTS:** Additional patrols have been requested following locations:

Orr Ferry House- Checked for vandalism, and or theft and any structural damage as result of recent storms

Sugar Hill City Barn-Checked the interior of the fenced in area for intruders and /or theft of City equipment.

Central City Park- Checked for unauthorized usage, i.e.: Picnicking, Fishing, and Any Other forms of Trespassing

Sugar Hill Golf Club-Check with Attendants for issues to include but not limited to unauthorized person/s.

E-center- Check of the 3<sup>rd</sup> floor doors at the vacant tavern. Check all restroom doors after Central City Tavern closes to insure they are locked and no doors are left unsecured.

Eagle Theater- Check for unsecured doors especially after events

The Bowl – All suites are to be checked to insure that unauthorized person/s have not accessed the 2<sup>nd</sup> floor audio room.

The Splash Pad and Plaza Areas- Insure that unauthorized activities are not taking place and that all activates unless City sanctioned are not taking place after 9 PM.

E-center –All Recreation Personnel are to be escorted to their vehicles at the prescribed times.

The Ducks at the pond are to be checked periodically for presence and to insure they are not being harassed.

Sugar Crest Drive- Patrol as often as possible in an attempt to make contact with a black pickup occupied by 3 W/M driving recklessly, inflicting property damage, and publicly urinating in the roadway. Any contacts notify GCPD.

Bailey Ave. - Check fence line for breaks in the chain link fence and illegal dumping

Sugar Hill Bakery/Café'- Any suspicious activity/ies.
