02.01-21 Mon – The Officer made patrols and had nothing to report.

02.02-21 Tue - The Officer made patrols and had this to report:

**INCIDENT: SUSPICIOUS ACTIVITY** – At 15:32 it was brought to our officer’s attention that the door at 4985 Bent Creek Ct Sugar Hill was open with no signs of occupants. Officer arrived and at the time could not contact any residents residing in the house, fearing a more serious issue may have occurred Officer retreated to the patrol car and called out Gwinnett P.D. At 05:55pm Officer Shellnut badge 262 arrived and was able to make contact with a young boy at the front door, upon talking with the boy’s mother who was also inside it was discovered that the child had simply come inside from playing and forgot to properly shut the door.
